eCPIC Access Glossary

Process Access:

Exhibit 53: Used to access the questions required to complete the OMB Exhibit 53 report for non-major investments.

Exhibit 300: Used to access and complete the OMB Exhibit 300 report for major investments. The Exhibit 300 also includes all questions on the Exhibit 53.

Investments:

Create: Allows the user to create new investments. Also allows the user to create new revisions of an

investment. A new revision stores an un-editable copy of the information for historical reference.

Revisions apply to individual investments only.

Read: Allows the user to read investment information only. The user may not make changes to investment

information. The user will also be able to run reports and export the investment information to Word

and Excel.

Update: Allows the user to change and edit investment information.

Portfolios:

Read: Allows the user to view the investments that are associated with a portfolio. The user can export the

list of investments to Excel as well as generate charts and graphs.

Update: Allows the user to add and remove investments that are in a portfolio.

Resource Library:

Read: Allows user to access and read documentation that is loaded into the Resource Library.

Upload: Allows users to upload documents into an investment's Resource Library. The upload access is

most often used for delivering quarterly control reviews.

Exhibit 53 Report Creation:

Allows the user access to the OMB reporting module to create and run Exhibit 53 reports based on the investment information within their portfolios.
