

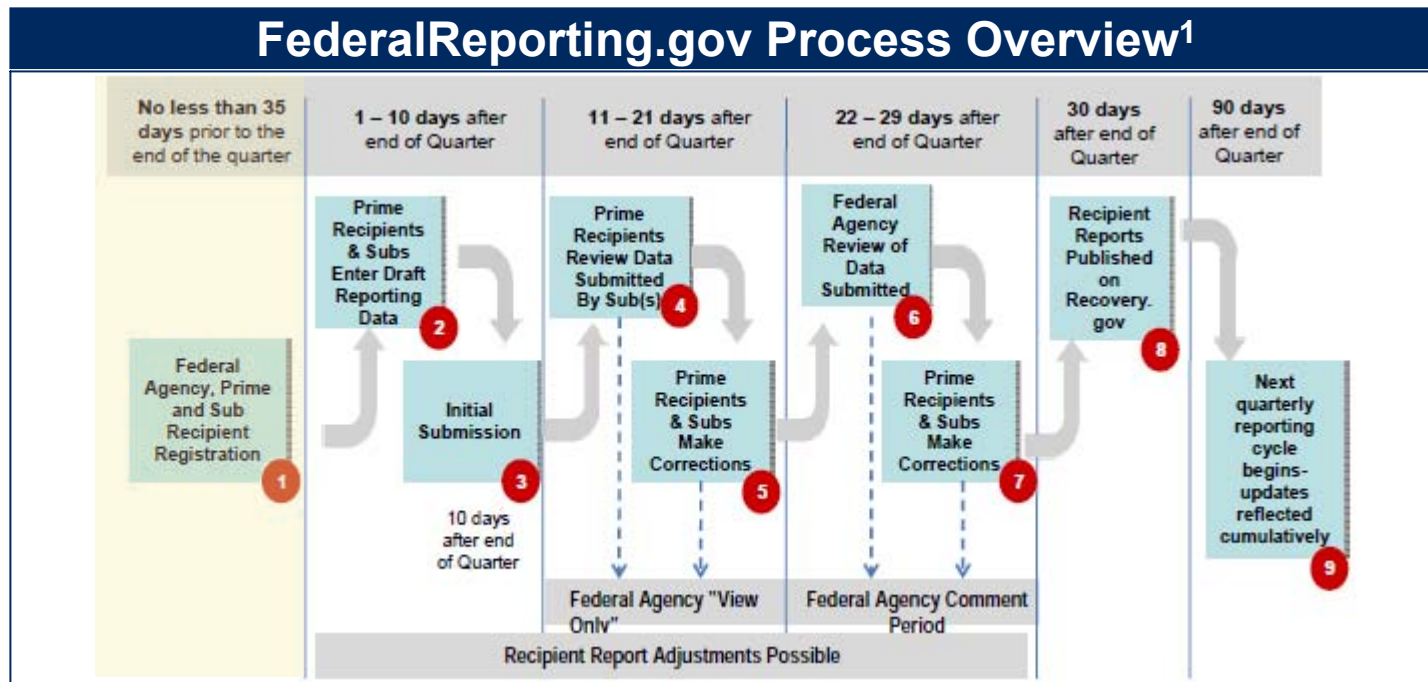

- Before filing first report, register online at <http://www.FederalReporting.gov>
- Registration can happen at any time and only needs to occur once



FederalReporting.gov Prime Recipient Registration Prerequisites:

DUNS Number

- Registration for a DUNS Number can be completed at the Duns and Bradstreet website: <http://fedgov.dnb.com/webform>.
- DUNS Registration may take several days to process.
- DUNS Number is required to register with CCR.



CCR Registration

- Central Contract Registration (CCR) is only required for Prime Recipients. ([CCR Registration Profile](#))
- Registration requires the recipient's organization Tax ID Number or Employer ID Number.
- CCR Registration may take several days to process.



Valid Email Address

- All registrants must have a valid email address.
- Users can create a free account by searching for “free email” in an online search engine.
- Valid email addresses are required to register in <http://www.FederalReporting.gov>

Email address, DUNS and CCR numbers are required for <http://www.FederalReporting.gov> registration.



Getting Started: Make sure you are prepared with the Checklist

- ☐ If it's 60 days before the end of the quarter, do you have your DUNS Number?

Tip: 60 days prior to the end of FY09 Quarter 4: July 30th
60 days prior to the end of FY10 Quarter 1: October 31st
60 days prior to the end of FY10 Quarter 2: January 31st
60 days prior to the end of FY10 Quarter 3: April 30th



- ☐ If it's 60 days before the end of the quarter, do you have your CCR Number?

- ☐ If it's 35 days before the end of the quarter, have you registered at <http://www.FederalReporting.gov>?

Tip: 35 days prior to the end of FY 09 Quarter 4: August 26th
35 days prior to the end of FY 10 Quarter 1: November 26th
35 days prior to the end of FY 10 Quarter 2: February 24th
35 days prior to the end of FY 10 Quarter 3: May 26th
