

SUMMARY

The Office of Regulation and International Engagement, Division of Natural Gas Regulation prepares quarterly reports on natural gas import and export activities. Companies are required, as a condition of their authorizations, to file monthly reports. This Natural Gas Import and Export Report is for the second quarter of 2015 (April through June).

Sections 1 and 2 contain quarterly summary charts and tables. Section 3 contains the detailed transactions of all imports and exports. The data in Section 3 are organized by activity: long-term imports, long-term exports, short-term imports, and short-term exports. Section 4 lists revisions made to data published previously. There is a table of contents for your convenience.

Second Quarter 2015 Highlights

U.S. imports totaled 636.3 Bcf and U.S. exports totaled 402.8 Bcf, resulting in net U.S. imports of 233.5 Bcf. As usual, most of the imports came from Canada, comprising 98.9 percent of the total. LNG imports and U.S. imports from Mexico made up the remainder, 1.1 percent of total imports. Mexico eclipsed Canada in natural gas exports, with 63.3 percent going to Mexico and 35.4 percent to Canada. The remaining amount was a LNG export by vessel to Taiwan.

Second Quarter 2015 vs. First Quarter 2015 - Highlights

As illustrated in the tables in Section 1, total imports decreased 21.5 percent compared to last quarter. Pipeline imports from Canada decreased by 18.5 percent, while pipeline imports from Mexico also decreased by 5.7 percent (although from a very small initial volume base). LNG imports decreased 81.6 percent. Canadian and Mexican import prices were both down from last quarter, 39.4 percent and 16.8 percent respectively. LNG import prices also fell by 24.2 percent.

Total U.S. exports were 402.8 Bcf, 9.0 percent lower than the first quarter total. A 22.7 percent increase in U.S. exports by pipeline to Mexico was offset by a 37.9 percent decrease in U.S. exports by pipeline to Canada and a shipment of a LNG exports to Taiwan. Prices of U.S. pipeline exports to Canada and Mexico decreased by 26.1 percent and 9.7 percent, respectively.

Additionally, there were two domestic LNG exports this quarter, 5.5 Bcf to Taiwan. Total trucked U.S. import volumes (for LNG and CNG) increased by 22.4 percent while total trucked export volumes (for LNG and CNG) increased by 2.4 percent. Total trucked U.S. export prices (for LNG and CNG) decreased by 42.1 percent and import prices (for LNG and CNG) decreased by 29.6 percent, compared to last quarter.

Second Quarter 2015 vs. Second Quarter 2014 – Highlights

Total U.S. imports were up 0.8 percent from the second quarter of 2014. Pipeline imports from Canada increased 2.2 percent, pipeline imports from Mexico decreased 38.6 percent (although from a small base), and LNG imports by vessel decreased 54.7 percent. The average price of pipeline imports fell 47.0 percent and LNG import prices also fell 36.8 percent. Trucked imports increased 176.3 percent from last year (although from a small base), with those prices falling 26.0 percent on average.

Total U.S. exports rose 13.2 percent compared to the second quarter of 2014. U.S. pipeline exports to Canada decreased by 16.1 percent and U.S. pipeline exports to Mexico increased by 38.3 percent. Total trucked exports increased by 4.6 percent. Overall, U.S. exports by pipeline increased by 12.2 percent while prices declined 40.9 percent, U.S. trucked exports rose 4.6 while their prices fell 30.0 percent, compared to the second quarter of 2014.

Imports and Exports of LNG by Vessel

LNG imports by vessel fell 81.6 percent compared to last quarter and fell 54.7 percent compared to the second quarter of 2014. Three LNG cargos (7.1 Bcf) were imported by vessel this quarter, compared to 14 cargos (38.4 Bcf) first quarter of 2015 and six cargos (15.6) in the second quarter of 2014. LNG import prices (by vessel) were 24.2 percent lower than last quarter and 36.8 percent lower than in the second quarter of 2014.

There were two exports of domestically-produced LNG in this quarter (5.5 Bcf), compared to none in the last quarter and one cargo in the second quarter of 2014 (1.9 Bcf). The U.S. did not re-export cargos of LNG in this quarter, compared to two re-exported cargos to Brazil in the last quarter (5.5 Bcf) and none in the second quarter of 2014.

During this quarter, five LNG cargos were delivered to Puerto Rico (13.3 Bcf), compared to six in the first quarter (13.0 Bcf) and seven in the second quarter of 2014 (16.1 Bcf).

2nd Quarter 2015











(\$/MMBtu)




- In the second quarter of 2015, the U.S. imported 636.3 Bcf of natural gas.
- A large majority of imports originated in Canada, continuing a long-term trend. Trinidad & Tobago was the next-largest supplier, providing one percent of imports.
- The remaining volume was supplied by one other country – Mexico.
- Import prices averaged in the range of \$1.70 per MMBtu (for a very small amount from Mexico) to \$6.66 per MMBtu for LNG vessels from Trinidad & Tobago, with a quarterly weighted average price of \$2.42.


Domestic Natural Gas Exports, 2Q 2015

(Bcf)




Avg. Export Price, 2Q 2015

- About 63% of U.S. exports of domestically-produced natural gas during the first quarter were sent to Mexico, while 36% were sent to Canada.
- Prices of exports to Mexico were higher than prices of exports to Canada, with an average price of exports to Mexico at \$2.86 per MMBtu compared to an average price of exports to Canada of \$2.82 per MMBtu.

Comparison of 2Q Imports with Previous Quarters (Bcf)



- The total volume of second quarter imports was significantly lower than the first quarter of 2015 and slightly higher than the second quarter of 2014.
- The decrease in imports relative to the first quarter of this year looks to be seasonal as the total imports for 2Q 2015 is relatively in line with the total imports for 2Q 2014, 636.3 Bcf to 631.4 Bcf.

(Bcf)



- Export volumes in the second quarter of 2015 were lower than the 1Q2015 and higher than the 2Q 2014, by -7.8% and 13.2%, respectively.
- Exports to Canada were lower than both first quarter 2015 and second quarter 2014.
- Exports to Mexico in the second quarter of 2015 were higher than both the first quarter 2015 and the second quarter 2014, following the trend of growth in exports to Mexico.
- There were domestically-produced LNG exports this quarter totaling 5.5 Bcf, with the destination country being Taiwan.

Pipeline Imports by Entry Point



- Volumes of natural gas imported under short-term authorizations continued to eclipse volumes imported under long-term authorizations at all entry points.
- Eastport, Idaho experienced the highest volume of imports from Canada, at 27% of the total. Sherwood, North Dakota and Port of Morgan, Montana had the second and third largest import volumes, accounting for 19.8% and 19.3% of the total, respectively.
- Continuing a trend of negligible imports from Mexico in recent years, only a small volume of natural gas was brought into the country from Mexico, through only one entry point, during the second quarter.


- St. Clair, Michigan continued to handle most exports by pipeline to Canada – more than 59% for the quarter.

2Q2015





LNG Import Volume by Country (Bcf)




- Trinidad & Tobago was the only supplier of LNG to the U.S. in the second quarter.
