Hope this will make sense on your end.

We have no record of W(A)-02-024. The contract, contractor, and date forwarded correspond to our waiver docket CH1108, W(A)-02-049 which was granted on 3-18-2003.

We have no record of W(A)-02-025. The contract, contractor, and date forwarded correspond to our waiver docket CH1118, W(A)-02-042 which was granted on 12-19-2002.

Perhaps these were somehow duplicated in HQ under two different HQ docket numbers?

S-98,035 is a CH case, but there is no record of W(I)-02-004. The computer invention database shows the invention was under a contract to Thermo Power, DE-FC36-97GO10134, and a SOC was forwarded to HQ on 7-12-2002. However, there is no waiver record entered. The case is assigned to Carol Williams, so I will have her pull the file to see what we can find. Looks like we didn't enter it in the waiver docket properly, but it also looks like we forwarded a SOC and petition to HQ last year. Maybe the file will help us tie this together.

The others are identified and I will have the responsible attorney get info to you.
