NOTICE OF ALLOWANCE TO RESUME DISTRIBUTION

Manufacturers of certain covered products which have been determined by the Department of Energy (DOE) to be non-compliant with the applicable energy conservation standard may be allowed to resume distribution, per 10 CFR § 430.70 (a)(6)(v), if additional testing results supplied by the manufacturer results in a determination of compliance. On June 14, 2010, DOE issued a Notice of Non-Compliance Determination based on test results submitted by Westinghouse showing that certain models were noncompliant. Westinghouse later admitted that the original test results were based on testing that was not performed in accordance with DOE regulations. Westinghouse has now conducted the testing required by DOE regulations and has submitted complete test data, which DOE has reviewed closely.

FINDINGS


Based on the new test data, DOE has now determined that the basic models that correspond to Westinghouse product codes 0521100, 0528400, 0351700, 0521300, 0352600, 0548400, 0548700, 0548600, 0521400, 3691700 and 3968900 comply with applicable DOE energy efficiency standards. As of August 5, 2010, Westinghouse may resume distribution of these products.

These represent 11 of the 12 product codes outlined in the June 14, 2010 Notice of Non-Compliance Determination. Westinghouse has not demonstrated that the remaining basic model 50PAR30_F (Westinghouse product code 0521000) is compliant; therefore, Westinghouse may not resume distribution of that basic model.


