**Proposed Action:** Lane-Wendson No. 1 Structure 10/5 Access Road Improvement and Pole

<u>Proposed by:</u> Bonneville Power Administration (BPA)

<u>Categorical Exclusion Applied (from Subpart D, 10 C.F.R. Part 1021)</u>: B1.3, Routine maintenance activities...for structures, rights-of-way, infrastructures such as roads, equipment...routine maintenance activities, corrective....are required to maintain... infrastructures...in a condition suitable for a facility to be used for its designed purpose.

<u>Location</u>: BPA is proposing to conduct road improvements and replace pole structure 10/5 along the Lane-Wendson No. 1 Transmission Line. The project is located in Lane County, Oregon, in BPA's South Region, Eugene District. Townships, Ranges, and Sections crossed by the proposed project are shown below.

Description of the Proposed Action: BPA has a need to replace wood pole structure 10/5 along the Lane-Wendson No. 1 Transmission Line. The pole structure which provides a tap for local power distribution customer Eugene Water and Electric Board (EWEB) is at eminent risk of failure. Lane-Wendson No. 1 structure 10/5 was installed in 1948 and is well beyond its functional lifespan. The pole structure and EWEB tap are located within a wetland north of Noti Creek. As a result of the wet conditions at the site, there is no vehicle access to Lane-Wendson No. 1 10/5. BPA needs to add rock to an existing road and construct approximately 230 feet of new road and landing area in order to replace the depilated pole structure and therefore ensure future system reliability to EWEB and their customers. All work will be in accordance with National Electrical Safety Code and BPA standards.

Findings: BPA has determined that the proposed action complies with Section 1021.410 and Appendix B of Subpart D of the Department of Energy (DOE) National Environmental Policy Act (NEPA) Regulations (57 Fed. Reg. 1512.2, April 24, 1992). The proposed action does not present any extraordinary circumstances that may affect the significance of the environmental effects of the proposal. The proposal is not connected [40 C.F.R. 1508.25 (a)(1)] to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts [40 C.F.R. 1508.25 (a)(2)], and is not precluded by 40 C.F.R. 1506.1 or 10 C.F.R. 1021.211. Moreover, the proposed action would not (i) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health; (ii) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities; (iii) disturb hazardous substances, pollutants, contaminants, or Comprehensive Environmental Response, Compensation and Liability Act-excluded petroleum and natural gas products that pre-exist in the environmentally sensitive resources.

With the actions identified on the attachment, this proposed action meets the requirements for the Categorical Exclusion referenced above. We therefore determine that the proposed action may be categorically excluded from further NEPA review and documentation.
