Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

Description:

A9 Information gathering (including, but not limited to, literature surveys, inventories, audits), data analysis (including computer modeling), document preparation (such as conceptual design or feasibility studies, analytical energy supply and demand studies), and dissemination (including, but not limited to, document mailings, publication, and distribution; and classroom training and informational programs), but not including site characterization or environmental monitoring.

Rational for determination:

Flint Geothermal LLC (Flint) would locate geothermal resources in Colorado by applying processed remote imaging data to search for geothermal resources, then more direct on-site methods would be used to confirm the resource. The project is divided into three phases with multiple tasks:

Phase 1 - Acquisition, Processing and Analysis of Remote Sensing Data

Tasks 1 through 3 consist of acquiring remote sensing data (Landsat, Modis, and Aster) collected over the last five years, processing and analyzing that data, then documenting results and making preliminary site selections of up to five prioritized prospective areas on which to conduct further investigation. The sites would be evaluated as to surface and mineral ownership and in order to begin on-site testing (Phase 2 and 3) any leases, permits, and/or access agreements would be obtained to secure access to the sites for testing.

Since the site locations have not been determined, Phase 2 and Phase 3 (excluding Task 12) activities cannot be analyzed at this time. A NEPA determination for the tasks in Phase 2 and Phase 3 (excluding Task 12) of the project would be too early to determine but would need to be made prior to UAF beginning any drilling.

Phase 2 - Conduct On-Site Geophysical and Temperature Surveys and Map Results

Tasks 4 and 5 include geophysical, direct testing, and temperature surveys.

Phase 3 - Drill, Core and Test Geothermal Resource (min. of two wells)

Tasks 6 through 12 consist of site preparation/mobilization, drilling, flow testing, data collection, analysis of data, and project management and reporting.

Reports and other deliverables would be provided in accordance with the Federal Assistance Reporting Checklist following the instructions included therein.

According to the R&D Laboratory Questionnaire, no permits would be needed for Phase 1 activities. Phase 1 laboratory work would predominantly consist of software development and analysis in a classroom/office setting at the University of Colorado (Boulder).

Condition of Approval: Allowable - Phase 1 (Tasks 1 through 3) and Phase 3 (Tasks 12 - "Project Management and Reporting"); Prohibited – Phase 2 and Phase 3 (all tasks other than 12).

Based upon the information provided, Phase 1 (Tasks 1 through 3) and Phase 3 (Task 12) are categorically excluded under CX A9 "Information gathering/data analysis/document preparation/dissemination."
