Description:

Rational for determination:

Vulcan Power Company (Vulcan) would demonstrate the potential geothermal resource at Colado, Nevada. Vulcan would collect and interpret data from geophysical works, drill 3 core holes, and follow with testing and evaluation. The BLM Humboldt River Field Office processed geophysical applications (Notice of Intents) with a categorical exclusion. The project would be divided into three Phases with multiple tasks. The following tasks are Categorical Excludable since the tasks include obtaining permits, and research the geothermal resource.

Phase I - Resource Evaluation

Task 1) Exploration Program Design: Design remote sensing radiation detection, surface mapping using aerial photography, 2-meter thermal surveys, self-potential (SP), gravity, magnetotellurics, and 2-D seismic reflection for implementation at the Colado geothermal prospect.

Task 2) Conduct Exploration Surveys: Remote Sensing Radiation Detection Survey, Surface Mapping Using Aerial Photographs, 2-meter Thermal Surveys, State-of-the-Art Geophysical Surveys,

Task 3) Analysis and Validation of Innovative Exploration Technologies: Analyze and validate the Innovative Exploration Technologies.

Phase II and III (except Task 6) are not Categorical Excludable since the geothermal coring locations have not been identified and therefore cannot be analyzed at this time.

Task 6.0 - Project Management and Reporting

According to Vulcan, safety protocols are in place for instruments, geophysical work, chemicals, and waste monitored by a Health and Safety officer that meet or exceed state and federal requirements.

At this time, the drilling locations of the geothermal core holes have not been identified, and therefore cannot be analyzed. Therefore, Phase II and III are not authorized (except Task 6). Phase II and III would be analyzed once the locations of the geothermal core holes are identified and submitted to the DOE.

Condition of Approval: Allowable: Phase I and Task 6; Prohibited: Phase II and III (except Task 6). This proposal comprises research, data analysis, and onsite characterization actions to promote the research and development of geothermal resources; therefore this project is categorized as CX A9 and B3.1.
