Proposed Action or Project Description

The University of Central Florida is dedicated to creating innovative programs that accelerate the commercialization of energy-related technologies developed within universities and national laboratories. The over-riding objective of the proposed Mega Watt Ventures Program is to connect promising research in energy efficiency with experienced entrepreneurs, etc. The scope of work includes the planning and implementation of three annual Mega Watt Ventures events. The first two years will be a pilot program focusing mainly on Florida universities. Year three will expand the program to include a network of universities located in the southeastern U.S. Tasks to be performed Phase I include: 1) project management and planning for technology transfer processes, 2) formation and planning of Mega Watt Ventures Board of Directors, 3) event management for first two Mega Watt Ventures events, 4) develop marketing plan for Mega Watt Ventures, 5) execute competition logistics, 6) execute post-event logistics. Tasks to be performed for Phase II include: 7) project management and planning for technology transfer processes, 8) expansion of Mega Watt Ventures Board of Directors, 9) event management for expansion to southeastern region, and 10) establish sustainable financial base to implement Mega Watt Ventures in perpetuity as a southeastern "regional qualifier" for NREL's Industry Growth Forum.
