Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

Weldall Manufacturing, Inc. will receive a \$300,000 SEP loan for the purchase of a robotic welding machine. The company is currently located in a 144,000 square-foot facility at 2001 S. Prairie Avenue in Waukesha, WI.

Weldall Mfg. will produce tanks and miscellaneous parts for the power transformers which can also be used for renewable power sources including power supplied by water, wind farms, and digesters. They also are developing and manufacturing advanced, innovative wind turbines. Weldall will build parts for the wind turbines.

All aspects of the proposed project will occur at the existing facility. No new construction or expansion of the existing building will occur as a result of the proposed project. No new permitting or licensing is needed for the expenditures of these funds.

Waste Stream Requirements

Prior to the expenditure of Federal funds to implement any of the above-mentioned activities, the State of Wisconsin has the affirmative responsibility to ensure or certify that it has been provided by its sub-recipients a waste management plan addressing waste generated by their proposed actions.
