Description:

A9 Information gathering (including, but not limited to, literature surveys, inventories, audits), data analysis (including computer modeling), document preparation (such as conceptual design or feasibility studies, analytical energy supply and demand studies), and dissemination (including, but not limited to, document mailings, publication, and distribution; and classroom training and informational programs), but not including site characterization or environmental monitoring.

## Rational for determination:

The Nevada Institute for Renewable Energy Commercialization proposes to use federal funding to continue efforts in developing renewable energy technologies and projects. This NEPA determination is a continuation of the GFO-08-138 NEPA determination.

NIREC will conduct an RFP for renewable energy projects, provide grant funding for commercialization of the selected projects, and support the grantees through the process of acquiring private funding to further the technology. NIREC expects to select projects in multiple technologies that include, but are not limited to, solar, wind, geothermal, biomass-biofuels, storage, hydrogen, and efficiency technologies in addition to infrastructure capabilities.

CX A9 applies to project management and activities in support of issuing the RFP. Projects selected by NIREC under the RFP are subject to additional NEPA review.
