American Recovery and Reinvestment Act:

The Tonkawa Tribe of Indians of Oklahoma proposes to replace the heating and cooling units in the Tonkawa Tribal Enterprise Building (Programs and Services Building). The project would also require renting equipment to remove the old roof top units and place the new units on top of the building.
