American Recovery and Reinvestment Act:

1) Consultant services; 2) residential and commercial building audits; 3) energy audits of county-owned buildings; 4) revolving loan fund; 5) retrofit county-owned building—replace chiller, boiler, and lighting at Washington County Health Center; refurbish air handling units, replace heat pumps, and replace lighting at Washington County Courthouse Square; replace boilers with high efficiency units, install variable speed drives on pumps, and replace lighting at Washington County Airport; 6) establish recycle program including purchasing recycling equipment and set-up materials, construction, and training; 7) traffic signal replacement program; and 8) solar hot water panel installations at the Correctional Facility.
