Multiple Structure Replacement Flaming Gorge to Vernal No. 1 138-kV Transmission Line Uintah County, Utah

- A. <u>Brief Description of Proposal</u>: Western Area Power Administration (Western) proposes to replace eight (8) wood H-frame structures along the Flaming Gorge-Vernal No. 1 138-kV transmission line. The structures are located on both private and Bureau of Land Management (BLM) lands in Uintah County, Utah, as indicated below:
 - 1. Structure 15/7 T1S, R23E, Section 16, Blair Basin 7.5' USGS quadrangle map
 - 2. Structure 20/5 T2S, R23E, Section 10, Blair Basin 7.5' USGS quadrangle map
 - 3. Structure 31/8 T3S, R22E, Section 26, Donkey Flat 7.5' USGS quadrangle map
 - 4. Structure 32/1 T3S, R22E, Section 35, Donkey Flat 7.5' USGS quadrangle map
 - 5. Structure 32/3 T3S, R22E, Section 35, Donkey Flat 7.5' USGS quadrangle map
 - 6. Structure 32/5 T3S, R22E, Section 35, Donkey Flat 7.5' USGS quadrangle map
 - 7. Structure 34/3 T4S, R22E, Section 11, Naples Quad 7.5' USGS quadrangle map
 - 8. Structure 35/3 T3S, R22E, Section 26, Naples Quad 7.5' USGS quadrangle map

Work consists of removing and in-kind replacement of the wood H-frame structures and anchors at the same locations as the existing structures. Work will utilize rubber tired vehicles, crane, bucket truck, pole trucks/trailers, auger rig, and pick-up trucks. Existing access roads will be used and minor grading may be conducted with a tracked bulldozer, only as needed, for access road maintenance and/or to level the landing areas.

B. <u>Number and Title of the Categorical Exclusion Being Applied</u>: (See text in 10 CFR Part 1021, Subpart D.)

B1.3 Routine maintenance.

Routine maintenance activities and custodial services for buildings, structures, rights-of-way, infrastructures (including, but not limited to, pathways, roads, and railroads), vehicles and equipment, and localized vegetation and pest control, during which operations may be suspended and resumed, provided that the activities would be conducted in a manner in accordance with applicable requirements. Custodial services are activities to preserve facility appearance, working conditions, and sanitation (such as cleaning, window washing, lawn mowing, trash collection, painting, and snow removal). Routine maintenance activities, corrective (that is, repair), preventive, and predictive, are required to maintain and preserve buildings, structures, infrastructures, and equipment in a condition suitable for a facility to be used for its designated purpose. Such maintenance may occur as a result of severe weather (such as hurricanes, floods, and tornados), wildfires, and other such events. Routine maintenance may result in replacement to the extent that replacement is inkind and is not a substantial upgrade or improvement. In-kind replacement includes installation of new components to replace outmoded components, provided that the replacement does not result in a significant change in the expected useful life, design capacity, or function of the facility. Routine maintenance does not include replacement of a major component that significantly extends the originally intended useful life of a facility (for example, it does not include the replacement of a reactor vessel near the end of its useful life). Routine maintenance activities include, but are not limited to:

- (a) Repair or replacement of facility equipment, such as lathes, mills, pumps, and presses;
- (b) Door and window repair or replacement;
- (c) Wall, ceiling, or floor repair or replacement;

(d) Reroofing;

- (e) Plumbing, electrical utility, lighting, and telephone service repair or replacement;
- (f) Routine replacement of high-efficiency particulate air filters;
- (g) Inspection and/or treatment of currently installed utility poles;
- (h) Repair of road embankments;
- (i) Repair or replacement of fire protection sprinkler systems;
- (j) Road and parking area resurfacing, including construction of temporary access to facilitate resurfacing, and scraping and grading of unpaved surfaces;
- (k) Erosion control and soil stabilization measures (such as reseeding, gabions, grading, and revegetation);
- Surveillance and maintenance of surplus facilities in accordance with DOE Order 35.1, "Radioactive Waste Management," or its successor;
- (m)Repair and maintenance of transmission facilities, such as replacement of conductors of the same nominal voltage, poles, circuit breakers, transformers, capacitors, crossarms, insulators, and downed powerlines, in accordance, where appropriate, with 40 CFR part 761 ("Polychlorinated Biphenyls Manufacturing, Processing, Distribution in Commerce, and Use Prohibitions") or its successor;
- (n) Routine testing and calibration of facility components, subsystems, or portable equipment (such as control valves, in-core monitoring devices, transformers, capacitors, monitoring wells, lysimeters, weather stations, and flumes);
- (o) Routine decontamination of the surfaces of equipment, rooms, hot cells, or other interior surfaces of buildings (by such activities as wiping with rags, using strippable latex, and minor vacuuming), and removal of contaminated intact equipment and other materials (not including spent nuclear fuel or special nuclear material in nuclear reactors); and
- (p) Removal of debris.

C. <u>Regulatory Requirements in 10 CFR 1021.410 (b)</u>: (See full text in regulation and attached checklist.)

1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal <u>must not</u>:

- Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;

- There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

D. Special Stipulations Pertaining to the Proposal:

If the scope of work of this project changes, Western's Environmental Division must be contacted for additional environmental review.

This Categorical Exclusion is valid for 3 years after the signature date. If construction has not commenced within that time, Western's Environmental Division must be contacted for an updated environmental review prior to construction.

If cultural materials are discovered during construction, work in the area shall halt immediately, Western and the Utah SHPO staff shall be contacted, and the material be evaluated by an archaeologist or historian meeting the Secretary of the Interior's Professional Qualification Standards (48 FR 22716, Sept. 1983).

All work will be conducted using existing access roads. Minor access road maintenance may be required. Maintenance crews will ensure the minimum construction footprint necessary to allow the pole replacements.

With the exception of Structure No. 34-3, all structures slated for replacement occur within elk and sage-grouse crucial winter habitat. Maintenance work will be scheduled to occur outside of the elk crucial winter range habitat guidelines established by the BLM. These guidelines indicate limiting activities from December 1 through April 30. Work shall also be scheduled and conducted outside the general nesting season between March 1 and July 31. If work is to be conducted during these seasonal guidelines, the maintenance crew will need to consult with Western's biologist to ensure that construction activities limit disturbances to elk and sage-grouse habitat.

Determination: Based on my review of information provided to me and in my possession concerning the proposed action, I determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
