Rational for determination:

The U.S. Department of Energy (DOE) provided funding to the City of Honolulu, Hawaii under the DOE's American Recovery and Reinvestment Act of 2009 Energy Efficiency and Conservation Block Grant Program (EECBG). Honolulu proposes to use \$77,000 to retrofit existing street lights.

The proposed project would retrofit approximately 100 street lights with LED bulbs and ballasts on residential streets. The proposed project does not include replacement of light poles or any trenching, existing poles and wiring would be utilized. The proposed retrofit would reduce the amount of energy consumed by the current street lights.

The proposed project would not have adverse effects on threatened and endangered species, wetlands, floodplains, or cultural resources, as these resources are not known to occur at the proposed sites. SHPO has provided a determination of no adverse effect to historic properties.

Based on review of project information and the above analysis, DOE has determined that the installation of the proposed lighting would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined the proposed energy efficient lighting is consistent with the actions contained in DOE categorical exclusion B5.1 factions to conserve energy" and is categorically excluded from further NEPA review

Any further projects will require a separate NEPA determination review.
