#### Rational for determination:

The U.S. Department of Energy (DOE) provided \$567,000 of federal funding to the State of Tennessee under the DOE's Annually Appropriated State Energy Program (SEP) for 2012. Tennessee will match the federal funding with \$113,400 in state funds. Additionally, Tennessee will carryover \$117,000 in federal appropriations, for a total of \$797,400.

Tennessee proposes to fund the following Market Titles:

Energy Assurance Planning:

Under this Market Title, funding would be used to support responsibilities under the Tennessee Energy Management Plan. Activities would include emergency planning seminars, maintenance of information relative to the Motor Fuel Contingency Plan, revision of the existing energy assurance plan to incorporate response action to new energy portfolios.

Energy Efficiency Schools Initiative:

Under this Market Title, Tennessee would use funding to provide energy management training opportunities, technical assistance and oversight for the Energy Efficiency School Initiative. Any activities funded under the 2012 annual appropriations that involve ground-breaking activities, retrofits, or equipment purchase and/or installation are conditioned pending additional NEPA review.

Grants Management:

Under this Market Title, funding would be used to support the continuing operation of the SEP activities performed by Tennessee Economic and Community Development personnel.

Public Education and Outreach:

Under this Market Title, funding would be utilized to promote awareness of energy initiatives through presentations, programs, workshops, and outreach material including websites and a toll-free Energy hotline.

Tennessee Energy Education Network (TEEN):

Under this Market Title, funding would provide training and support for teachers and other education professionals

Funds would be subgranted to the University of Tennessee 4H program to award up to 76 grants to local 4H programs to provide energy education kits and other materials.
