Rational for determination:

The U.S. Department of Energy (DOE) provided \$271,000 of federal funding to the State of Maine (ME) under the DOE's Annually Appropriated State Energy Program (SEP) for 2012. ME will match the federal funding with \$54,200 in state funds.

ME proposes to fund the following market titles:

Administration:

Under this Market Title, federal funding would be used to collaborate with other agencies to coordinate state energy policy, to prepare energy policy reports and presentations, and to provide technical assistance to the Governor and the Legislature. Additionally, partnerships to support state energy policy goals would be sought and monitoring of energy transmission policy and capacity planning would be conducted. The Maine Energy Assurance and Emergency Management Plan would be updated. Federal funds would also be used to promote the state on various energy committees. Finally funds would be used to explore the feasibility of ocean energy projects and to work with state utilities to develop policy for a pilot program (no federal funds will be used for final design or to fund the pilot program).

Comprehensive State Energy and Oil Reduction Planning:

Under this Market Title, federal funding would be used to revise Maine's energy plan and to establish a new plan for reducing oil consumption throughout Maine.

Energy Education:

Under this Market Title, federal funding would be used to provide training programs for trade organizations (HVAC,
