Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rational for determination:

This NEPA determination is being conducted for Budget Period 2 (BP) of this award. BP1 was reviewed and signed in May of 2009. Project activities reviewed in that determination were consistent with those covered under DOE CX A9 and A11.

The Small Wind Certification Council (SWCC) is proposing to use BP2 funding to continue work conducted under BP1, for small turbine outreach/certification, as well as move forward with a new proposed task, 5.0 (subtasks 5.1-5.6), focusing on outreach/certification for mid-sized wind turbines.

Under Task 5, SWCC would develop a program to certify medium wind turbines to the power and acoustic performance requirements of the IEC and work with Standard Development Organizations to develop more comprehensive standards for turbines of that size. Funding would not be used to purchase or construct mid-sized wind turbines, but would be used to certify them under new standards once they are available.

DOE has determined that impacts to the natural and human environment is expected to be negligible and that this project is consistent with actions covered under DOE CX A9 (information gathering, data analysis, document preparation and dissemination, and informational programs) and CX A11 (technical advice and assistance to organizations) and therefore is categorically excluded from further NEPA review.
