**Rationale for determination:**

The U.S. Department of Energy is proposing to provide federal funding to Eletricore, Inc. to develop a simulation and decision support toolset to assist the utility market and real time desk personnel for effective integration of centralized and distributed solar power generation.

Electriccore would conduct desk-top level data gathering and analysis and verification though computer modeling to create a support toolset that would assist in the integration of utility-scale and distributed solar generation into utility grid operations. Activities would involve data collection and analysis, materials development and computer modeling.

DOE has determined that this project is consistent with actions covered under DOE CX A9 (information gathering, data analysis, document preparation and dissemination, and computer modeling) and therefore is categorically excluded from further NEPA review.
