Proposed Action Title: GCS 345kV - SF6 Breaker (3396) and Concrete Pad Installation

Program or Field Office: Western Area Power Administration, Desert Southwest Regional Office

Location(s) (City/County/State): Page, Coconino County, Arizona

Proposed Action Description:

Western proposes to install a new 345kV - SF6 (sulfur hexafluoride) gas breaker (identified as 3396) in the Upper Yard of the existing Glen Canyon Substation. The amount of gas is approximately 320 pounds. The proposed work will require the construction of new equipment pad and foundation. Trench work of approximately two feet deep, three feet wide, and fifty feet in length will be installed from the control cabinet to cable tray to house duct work. The existing SF6 'live tank" breaker is nearing its life expectancy and will be replaced by a SF6 "dead tank" breaker to provide ease of maintenance, reliability, safety, and environmental requirements.

The project is located on BLM (Bureau of Land Management) withdrawn (Western fee-owned) lands at the existing Glen Canyon Substation in Page, Coconino County, Arizona; Sections 24 and 25, Township 41N, Range 8E of the Gila and Salt River Baseline and Meridian.

All equipment staging will be located inside the existing fenced boundary of the yard which is bladed, leveled, and graveled. Access to the project via existing public roads. The equipment used on-site will include a crane, flatbed trailer, bucket truck, backhoe, man-lift, and crew trucks.

Project activities are anticipated to start approximately in March 2014 with an estimated completion of no later than September 2014.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
