MANAGEMENT (MG)

OBJECTIVE

- 3. WCRR management has implemented an effective Integrated Safety Management System (ISMS) in accordance with an approved ISMS Description. Line Management is responsible for safety.
- 4. TRU-SO-1702, *Assignments of WCRR Managers and Supervisory Positions* meets the requirements of the TSR and has been effectively implemented and is consistent with the Laboratory commitments in the ISMS Description. (DOE P 450.4u, WCRRF TSR 5.2.1, and WCRRF TSR 5.2.2)
- 5. Personnel exhibit an awareness of public and worker safety, health, and environmental protection requirements and, through their actions, demonstrate a high priority commitment to comply with these requirements.

MG.2

OBJECTIVE

MG .2: A feedback and improvement process has been established to identify, evaluate, and resolve deficiencies and recommendations made by independent review groups, official review teams, audit organizations, and operating contractor. (CR 15)

CRITERIA

- 1. WCRR has an effective feedback and improvement program, including reviews and audits that meet Contractor Assurance Program expectations of DOE O 226.1. The program achieves the commitments in the approved QAP and ISMS Description and is compliant with TSR 5.5. (WCRRF TSR 5.5; DOE O 226.1; DOE P 450.4)
- 2. WCRR is supported by an effective issues management process or program in that all issues identified are tracked; corrective actions are developed and accomplished. This includes issues identified during WCRR construction, testing, and readiness assessment activities (DOE O 414.1C; CFR 830.120)
- 3. Management has reviewed all open issues related to WCRR and verified that no single open deficiency or group of deficiencies preclude safely starting nuclear operations. (10 CFR 830.120)

MG.3

OBJECTIVE

MG.3: The breadth, depth, and results of the responsible contractor Readiness Review are adequate to verify the readiness of hardware, personnel, and management programs for operation. (**CR 17**)

CRITERIA

- 1. The CORR implementation plan met the requirements of the approved Plan of Action (POA). (DOE O 425.1C)
- 2. The CORR Team members were qualified to assess the subjects and technical areas to which they were assigned. (DOE O 425.1C)
- 3. The CORR as documented by the final report was adequate in breadth and depth to determine the readiness of WCRRF to start nuclear operations. (DOE O 425.1C)
- 4. Issues, omissions, anomalies, etc identified during the CORR were properly categorized as to pre-start findings, post-start findings, or observations. (DOE O 425.1C)
- 5. Corrective actions to resolve CORR findings were appropriate and effective. (DOE O 452.1C)
- 6. Appropriate issues management processes were applied to determine the extent of the conditions and resolve the underlying causes for the findings. (DOE O 425.1C)
- 7. Documentation of finding resolution was adequate. (DOE O 425.1C; 10 CFR 830.120)
