

DOE Tribal Multi-County Weatherization Program October 2010



Brief Summary of Tribe

The Scotts Valley Band of Pomo Indians is located in Northern California with tribal offices located in Lakeport, Lake County and the City of Richmond, Contra Costa in California. The current Tribal membership consist of 227 members. Scotts Valley is a landless Tribe and currently has 23 acres in fee simple status in Lake County.

Project Overview

The program promotes Tribal energy selfsufficiency, social & economic development, employment opportunities, and training for Tribal communities on the creation of energy efficiency and renewable energy.

As building knowledge and skills is essential to developing, implementing, and sustaining energy efficiency and renewable energy development projects, the program also offers energy education.

The goals of the proposed project are:

- Training to bring renewable energy and energy efficiency jobs to Indian Country
- Enhance Tribal capacity through energy education and training
- Improve local Tribal economics and the environment
- Make a difference in the quality of life of California Indians





Weatherization Works! It creates significant benefits for California Tribes by providing long-term solutions for energy problems. Weatherization measures decrease energy use in the tribal home, while increasing the comfort level. These cost-effective measures create energy savings for lowincome families and economic and environmental benefits for the community. It can work on your Rancherial

HERE ARE FEW HOME ENERGY SAVING TIPS



Turn off your lights when not using. DO use compact fluorescents in fixtures and lamps. DON'T use them in places that are only lit for an hour of so. DO use them in hard-to-reach fixtures DON'T use them In fixtures and lamps that are turned off frequently.



If you notice a puddle or dripping Water Faucet, it probably indicates a leak and will need to be fixed. The sooner it's fixed the more likely your water bill will save money and energy costs.

Watch your Refrigerator, they cost \$5 to \$8 per month to operate and consume 3-5% of your home's total energy use. To keep out warm room air, keep the door closed as much as possible. If you have more that one refrig-erator or freezer and one doesn't get much use, unplug it and save energy COSTS

More TIPS To Save

\$\$S..... Lower your water temperature. Your hot water is probably hotter than necessary. Most are set at 140 degrees, turn it down to 120 degrees

Insulate your water heater by wrapping the tank in a blanket of fiberglass insulation will reduce heat loss by 25-40%. This means a saving of 4-9% on your water-heating bill

Replace your showerhead, replace it with a quality low-flow showerhead that will allow to use only 1-2 gal of water a minute instead of 8 gal a minute.

Plug those leaks. On a cold windy day, do you feel those breezes blowing through your house? On windows and doors use weather stripping, caulk around wall outlets, use door sweep on bottom of doors and seal around baseboards, gaps around pipes and small holes. Remember every hole plug means fewer drafts, a cozier home and lower heating bills.

Collaboration

The program success depends on working collaboratively with other organizations

- Developed MOU for weatherization apprenticeship program (EETA vs. NCES)
- Working closely with the California State unemployment office to identify green job opportunities for newly trained Tribal members
- Developed relationship with the Pinoleville Tribal Voc-Rehab Program for trainees to receive vocational benefits
- Work closely with internal Tribal Housing Dept. on buy-in for weatherization services

Collaboration

 GRIDS Alternative: Working closely with **GRIDS** Alternative (a subcontractor through CPUC/PG&E) to promote and recruit Mendocino and Lake County Tribes to participate in the Single-Family Affordable Solar Homes (SASH) program. The SASH program is for low-income homeowners that qualify for solar systems on their homes. So far, two homes have received solar systems and 10-15 are in the approval process.

Project Expectations

The following tasks are now in progress:

- Building Performance Institute Training
- More advanced Energy Efficiency Training
- Weatherization Apprenticeships
- Outreach to Tribes
- Economic Development Opportunities
- Green Job Opportunities
- Research Green Grant Opportunities
- Integrate Grant Tasks to enhance program objectives

Future Plans

- To access state or federal funding to start up a Tribal Weatherization Assistance Program (WAP)
- To qualify tribal homeowners for weatherization services from energy assistance providers and available solar technology, such as solar panels, solar water panels, and geothermal

Future Plans

- Promote and encourage entrepreneurs to start up energy efficiency businesses
- Create a local in-house energy efficiency resource library
- Utilize trained Tribal members to have job placements within their Tribes (housing)
- Encourage Tribes to attend free energy efficiency classes provided by PG&E (CA utility provider) to maintain skills
