Project Title: Routine Activities at Pinellas

Location: Pinellas County, Florida, Site

Proposed Action or Project Description:

LM is proposing to continue various routine monitoring, maintenance, inspection, and administrative activities that would be conducted by LM and Legacy Management Support (LMS) staff at the Pinellas County, Florida, Site. These activities are essential to meeting LM's overall mission to protect human health and the environment and to manage legacy land and assets.

Proposed activities include the following:

• Groundwater and surface water monitoring and sampling: Efforts include installation, abandonment, and sampling of groundwater monitoring wells; sampling surface water; monitoring equipment calibration and maintenance; well repair, maintenance, and development; laboratory analysis of samples; and generation and management of investigation-derived waste.

• Conducting methane and volatile organic compound assessments, which would involve the installation, purging and screening, and sampling of additional Vapor Pin device sampling locations.

- Conducting inspections.
- Land surveying.
- Administrative actions to support and maintain the Pinellas site, which may include the following:

Coordinating with the state agency, Florida Department of Environmental Protection; Pinellas County, which owns the property; and surrounding property owners. Other administrative activities including maintaining or revising the Resource Conservation and Recovery Act Hazardous and Solid Waste Amendments permit, preparing and entering into agreements or easements with the county and surrounding property owners, and amendment and extension of these agreements or easements.
