Pursuant to the above-referenced Orders, Sabine Pass Liquefaction, LLC ("Sabine Pass"), herein submits its semi-annual report for September 1, 2022, through February 28, 2023. This report includes information on the status of the long-term contracts associated with the long-term export of LNG and any long-term gas supply contracts.

- Sabine Pass submitted the following new long-term contract(s) associated with the long-term export of LNG from the Sabine Pass Terminal during the reporting period:
 - On November 1, 2022, Sabine Pass entered into an agreement with Cheniere Marketing International LLP for the long-term sale and export of liquefied natural gas from the Sabine Pass Terminal.
- Sabine Pass submitted the following new long-term gas supply contract(s) during the reporting period:
 - On January 19, 2023, Sabine Pass entered into a Gas Supply Agreement with Paloma Natural Gas LLC for an annual contract quantity of approximately 36,000,000 MMBtu.
 - On November 17, 2022, Sabine Pass entered into a Transaction Confirmation with EOG Resources, Inc. governed by that certain NAESB Base Contract for Sale and Purchase of Natural Gas dated January 1, 2015, for an aggregated annual contract quantity approximately 20,000,000 MMBtu in the first contract year, and approximately 40,000,000 MMBtu for each remaining contract year thereafter.
 - On November 10, 2022, Sabine Pass entered into a Transaction Confirmation with SWN Energy Services Company, LLC governed by that certain NAESB Base Contract for Sale and Purchase of Natural Gas dated November 1, 2013, for an aggregated annual contract quantity approximately 180,000,000 MMBtu in each of the first 4 contract years, and approximately 90,000,000 MMBtu for the final contract year.

- On October 17, 2022, Sabine Pass entered into a Gas Supply Agreement with Scona LLC for an annual contract quantity of 37,000,000 MMBtu in the first contract year and approximately 73,000,000 MMBtu for each remaining contract year thereafter.
- Sabine Pass submitted the following item(s) related to previously entered long-term gas supply contract(s) during the reporting period:
 - On March 15, 2022, Corpus Christi Liquefaction Stage III, LLC ("CCLIII"), Sabine Pass, and Tourmaline Oil Marketing Corp. ("Tourmaline") entered into an Assignment, Assumption and Consent Agreement, which assigns to Sabine Pass the previously submitted Gas Supply Agreement entered into by CCLIII and Tourmaline on July 29, 2021.
