Subject: DOE/FE Order No. 3765

On December 31, 2015, the Office of Fossil Energy of the Department of Energy issued DOE/FE Order No. 3765, an "Order Granting Long-Term Authorization to Import and Export Natural Gas from and to Canada" under section 3 of the Natural Gas Act. The Order specifically authorizes Irving Oil Commercial GP and Irving Oil Terminals Operations Inc. (collectively, Irving) to import up to 10 billion cubic feet (Bcf) of natural gas per year from Canada and to export up to 22 Bcf per year of natural gas to Canada. The term of the authorization is 15 years, beginning on November 1, 2017.

Recently, Irving Oil Terminals Operations Inc., a U.S. entity with its principal place of business in Portsmouth, New Hampshire, changed its name to Irving Oil Terminals Operations LLC. Copies of the relevant certificates are attached.

Earlier this year, the company notified Mr. Nussdorf, the DOE attorney who had handled the license application in 2015, of the anticipated change in name. He instructed the company that when the change occurred to send an email to the Office of Fossil Energy and request an amendment to the Order. Accordingly, Irving hereby respectfully requests that the Office of Fossil Energy amend DOE/FE Order No. 3765 to reflect the change in name of Irving Oil Terminals Operations Inc. to Irving Oil Terminals Operations LLC. Irving asks that the amendment be issued as soon as possible so that the company may commence importing and exporting natural gas from and to Canada as contemplated by the Order.
