### Proposed Action or Project Description:

LM is proposing to conduct routine activities at the Legacy Management Business Center (LMBC) located in Morgantown, West Virginia. Proposed activities would include administrative records storage and maintenance and routine operations and maintenance of equipment and assets. Proposed actions would be necessary to meet LM's program regulatory and statutory requirements for records and data storage and management in addition to providing administrative and Information Technology actions and routine maintenance on records and data storage-related equipment.
