#### **Award Fee Scorecard:**

The Total Available Award Fee has two components of fee: (1) adjectival (subjective) award-fee and (2) performance-based incentive (PBI) (objective) award-fee. The criteria for each are established for every evaluation period within the Contract Period of performance (Base Period, Option Period 1, and Option Period 2). The Total Available Award Fee for FY23 Evaluation Period is split Adjectival Award Fee (30%) and PBI Award Fee (70%). Each evaluation period aligns with the Government FY evaluation period. The total available award fee for this reporting period is \$17,152,667.94. Total award fee earned is \$13,231,568.05 (77%), comprised of subjective award fee at \$3,746,142.68 (73%) and objective award fee at \$9,485,425.37 (79%).

- Surpassed goals for shipping Transuranic waste, with 59 shipments to WIPP.
- Supported EM-LA's interactions with regulatory agencies, stakeholders, and Pueblos.
- Improved organizational participation in Contractor Assurance System (CAS) and resolution/closeout of CAS issues.
- Improved quality of root cause analyses, fact findings, and proposal documentation.

- Significantly improved nuclear safety, particularly on the Area G DSA.

## **Opportunities for Improvement:**

- Improve management coordination with EM-LA on key deliverables and schedule by increasing integration and communications both within and external to N3B.
- Improve invoicing and cost control reporting, particularly in carry over and parent company expenses by improving transparency and timeliness of fiscal reporting. Additional detail is warranted on key deliverables by providing more detailed synthesis of numerical values, such as a breakout of relevant contributing factors to both the cost performance index (CPI) and schedule performance index (SPI).
- Improve internal organizational coordination by improving cohesiveness of messaging and commitments made.
