Project Title: Routine Administrative, Maintenance, and Monitoring Activities at the Hallam, Nebraska, Decommissioned Reactor Site

Location: Hallam, Nebraska, Decommissioned Reactor Site

Proposed Action or Project Description:

LM is proposing to conduct routine administrative, maintenance, and monitoring activities at the 1.4-acre Hallam site to maintain the site's condition and upkeep. The Hallam site is located on the Sheldon Power Station.

Proposed activities would include the following:

- Annual Legacy Management Support contractor site visits and inspections
- Groundwater sampling of area wells (every 5 years)
- Routine maintenance as needed, including but not limited to the following: mowing and turf management; painting, patching cracks and similar repairs to surface components, sprinkler system, and monitoring wells
- Renew access agreement, as needed

The proposed activities would be nondisturbing routine work occurring on the site, which is a previously disturbed and remediated area. The mowing subcontractor would not utilize fertilizer or pesticide applications on the site; only small quantities of occasional spot herbicide would be used, as necessary.

- The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1501.9(e)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.1(g)(3)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized by the LM Director per DOE Policy 451.1), I have determined that the proposed action fits within the specified classes of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
