<u>Proposed Action Title</u>: (0670-2099) United Technologies Research Center - Additive Manufacturing of Optimized Ultra-High Efficiency Electric
Machines

Proposed Action Description:

Funding will support efforts to develop and test additive manufacturing, a new method for manufacturing induction motors without rare earth materials that enables greater design flexibility. Project tasks will be conducted in dedicated industrial and university laboratory, testing, and office facilities at United Technologies Research Center (East Hartford, CT), Pennsylvania State University - Applied Research Lab (University Park, PA), the Connecticut Center for Advanced Technologies (East Hartford, CT), and Ricardo, Inc. (Van Buren Township, MI). All project tasks will be conducted in accordance with institutional safety and materials/waste management protocols established at each facility and pursuant to applicable Federal, State, and local regulatory requirements.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
