UESC Contract Standardization

- UESC Contracting Officers Guide Book
 - Completed in April
 - Contracting document samples and templates
 - ➤ Contains other resources and tools including a timeline and check list to track project progress
 - > Includes templates that are easily modified to address each agency's unique acquisition requirements
- Guidebook is posted on FEMP website
- Samples are out at the registration desk
- All attendees may pick up a CD version
- Advanced UESC Workshop attendees already got one



UESC Training

- Workshops

Targeted Utility Rebate & Incentive Outreach

- IOU's offer over \$5 Billion in rebates and incentive each year
- Federal participation is generally low
 - > Don't realize what's available
 - Don't know they can accept rebates
 - > Not on the radar
- Utility provides relevant program information to FEMP
- FEMP compiles a one-pager including Federal requirements and authorities
- FEMP works with utility to identify Federal customers in territory
- FEMP sends e-mail blast to customers, DEPARTM

UESC Project Support and Data Collection

- FEMP can provide project support at any stage of your project
 - >Acquisition support
 - > Technical proposal review
 - >Support tailored to the need of site
- Data Collection
 - > We need your project data
 - ➤ Both appropriated and financed projects
 - ➤ We will even help you with OMB Max reporting
