ENERGY EFFICIENCY AND CONSERVATION BLOCK GRANTS PROGRAM NOTICE 10-012 EFFECTIVE DATE: May 4, 2010

**SUBJECT:** DAVIS-BACON ACT WAGE RATES FOR ARRA-FUNDED ENERGY EFFICIENCY AND CONSERVATION BLOCK GRANT (EECBG) PROGRAM PROJECTS INCLUDING RESIDENTIAL WEATHERIZATION WORK

**PURPOSE:** Provides guidance on using appropriate prevailing wage rates for all Davis-Bacon Act (DBA) covered-work, including weatherization work, performed under the Energy Efficiency and Conservation Block Grants (EECBG) Program using American Recovery and Reinvestment Act of 2009 (ARRA) funds to ensure compliance with DBA requirements.

**SCOPE:** The provisions of this guidance apply to Recipients of EECBG funds, as named in a Notification of Grant Award (Grant Award) from DOE under the EECBG and their subrecipients. This guidance does not apply to U.S. Territories. Tribal governments are only exempt from DBA provisions when the Tribal government performs work using its own employees. The DBA applies to all contractors and subcontractors that employ laborers and/or mechanics performing work under a Grant Award.

**GUIDANCE:** DBA-covered work performed by laborers and mechanics employed by contractors and subcontractors on EECBG ARRA-funded projects, including residential weatherization work, **must** use the existing residential construction prevailing wage rates as published by the Department of Labor (DOL) at: <a href="http://www.wdol.gov">http://www.wdol.gov</a> and provided in the spreadsheet tables found at: <a href="http://www1.eere.energy.gov/wip/davis-bacon\_act.html">http://www1.eere.energy.gov/wip/davis-bacon\_act.html</a>. These look-up tables are ordered by state and county and each spreadsheet lists the relevant work categories for that jurisdiction. Please note that the specially-developed "Weatherization" wage rates must *not* be applied for EECBG program expenditures (note: DOL has determined that the Weatherization wage rates may only be applied to funds provided specifically under the Weatherization Assistance Program).
