**Laramie County, Wyoming**

- A. Brief Description of Proposal:** Western Area Power Administration (Western) proposes to replace six existing wood-pole structures along the Archer-Cheyenne South (ARH-CH S) and Archer-Cheyenne North (ARH-CH N) 115-kV Transmission Lines. The structures were identified as deficient and in need of replacement by Western crews. Western's wood structures that will be replaced are structures 6/3, 6/4, and 6/5 on the ARH-CH N line and structures 6/2, 6/3, and 6/4 on the ARH-CH S line. The structures are wood H frame and will be replaced in-kind.

Construction activities proposed for ARH-CH N and S 115-kV transmission line pole replacement project include the removal of the existing wood structures, augering and installing new wood poles, backfilling, and adding new hardware. The equipment utilized includes 4-wheel drive pick-ups, rubber-tired motor digger/derrick, manlift, skid-steer loader, pole trailer, and line trucks. All work will be confined to Western's right-of-way easement. Existing access will be used and no new roads are proposed. The project is scheduled for spring 2014.

- B. Number and Title of the Categorical Exclusion Being Applied:** (See text in 10 CFR Part 1021, Subpart D.)

**B4.13 Upgrading and rebuilding existing powerlines**

**Upgrading or rebuilding approximately 20 miles in length or less of existing electric powerlines, which may involve minor relocations of small segments of the powerlines.**

- 1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to those listed in paragraph B. (4) (see Attachment A).

- 2) There are no extraordinary circumstances related to the proposal that may affect *the significance of the environmental effects of the proposal*.
- 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

**D. Special Stipulations Pertaining to the Proposal:**

If the scope of work for this project changes, Western’s Environmental Division must be contacted for additional environmental review.

This Categorical Exclusion is valid for 1 year after the signature date. If the project has not commenced within that time, Western’s Environmental Division must be contacted for an updated environmental review prior to construction.

If any used treated wood poles or cross-arms are donated, Western will obtain a signed “acknowledgment of receipt” of Western’s Consumer Information Sheet for Treated Wood Poles and Cross-Arms from the person receiving the used poles and/or cross-arms.

If any cultural materials are discovered during construction, work in the area shall halt immediately, Western’s Rocky Mountain Region Regional Preservation Officer shall be contacted, and the material be evaluated by an archaeologist or historian meeting the Secretary of the Interior’s Professional Qualification Standards (48 FR 22716, Sept. 1983).

All equipment used will be cleaned prior to use in the area to prevent transporting of invasive plant or noxious weed seeds.

To comply with the Migratory Bird Treaty Act, maintenance work should be scheduled outside the March 1 through July 31 general nesting periods. If the maintenance work is to be done during this period, contact Western’s Environmental Division so that they may arrange for a pedestrian survey to be conducted in advance of the maintenance crews to identify active nests that are to be avoided.

Western shall exercise care to preserve the natural landscape and shall conduct this construction operation to prevent any unnecessary destruction, scarring, or defacing of the

natural surroundings in the project vicinity. Except where clearing is required for permanent works, approved construction roads, or excavation operations, vegetation shall be preserved and shall be protected from damage by Western's construction operations and equipment.

- E. Determination:** Based on my review of information provided to me and in my possession concerning the proposed action, I determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
