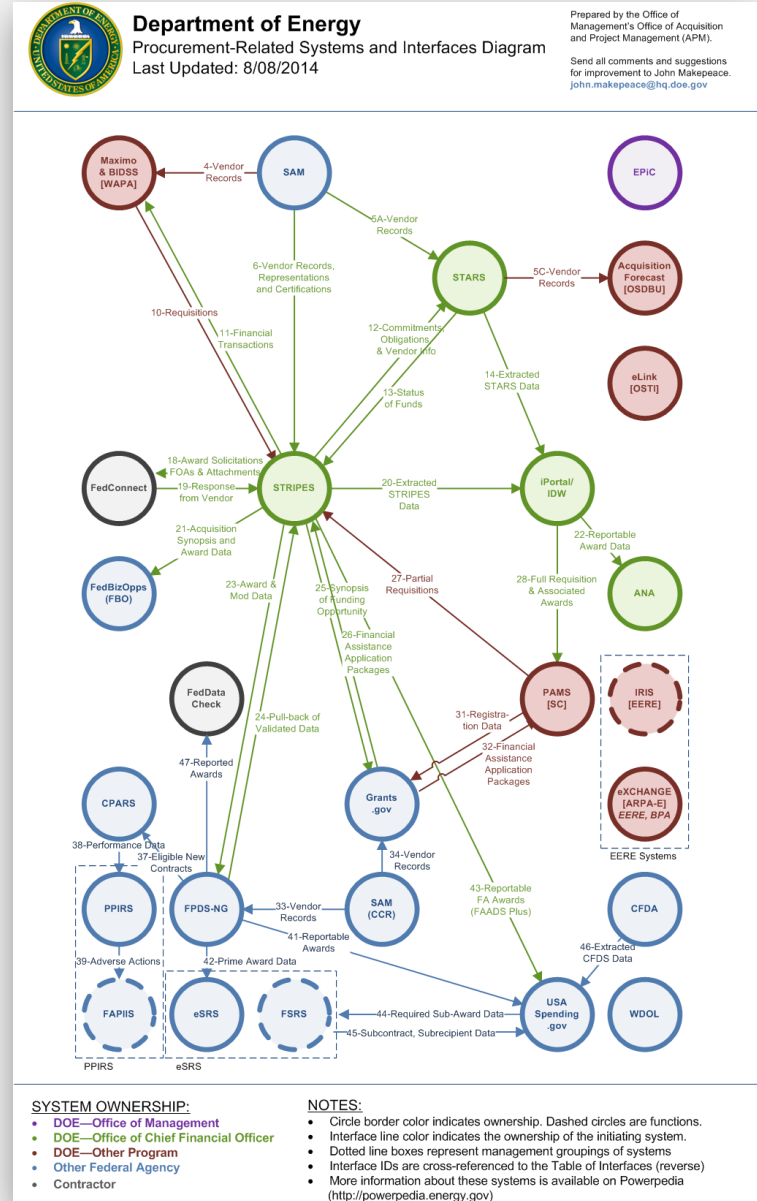
DOE performs over 30,000 procurement actions every year

Procurement Community

- 30+ procurement offices
- 900+ requisitioners
- 900+ contracting specialists and officers

22 procurement-related systems:

- 10 DOE systems
 - 5 Corporate
 - 5 Site-specific
- 10 federal Systems
- 2 Commercial Systems



- Since Last Workshop...
 - STRIPES 7.1 implemented in June 2014
 - Redesigned the requisition module
 - PADS Fully Decommissioned
 - Created 60+ new IDW reports to replace the old PADS reports
 - Created improved process for reporting financial assistance actions to USASpending.gov
 - EnCoRe Decommissioned
 - Functionality now provided by STARS
- What's Up Next?
 - STRIPES 7.2 Upgrade Scheduled for May/June 2016
 - Complete Redesign of the Acquisition module
 - Configuration workshops to be scheduled
 - Robust training is being planned
 - STRIPES 7.3 TBD
 - Complete Redesign of the Financial Assistance module
 - M&O Subcontract Reporting Capability (MOSRC)

- Government-wide small business target:
 - Award 23% of prime contract obligations to small businesses
- DOE's conundrum
 - 74% of our prime contract obligations are awarded to M&Os (FY 14)
 - Leaves just 26% of our obligations available for award to small businesses
- Congressional relief
 - Consolidated Appropriations Act of 2014, Title III, Section 318
 - Authorizes DOE to count the M&O's first-tier small business subawards toward accomplishment of our small business goal
 - Additional data is required from the M&Os in order to meet SBA's validation, reporting, and prime goal setting needs
- The MOSRC solution
 - Modify M&Os business systems & processes
 - Create central DOE database to collect, store & report this data
 - Three-year phased deployment:
 - FY 15 M&Os: ORNL (SC), NSC (NNSA), SRS (EM), ??? (S-4/Energy)

- Since Last Workshop...
 - Established the Procurement Insight Center (PIC)
 - 20+ types of standard reports in IDW (50+ unique reports)
 - Includes reports used for calculating Critical Few metrics
 - Provides a visual catalog to help you find the right report
 - Trained/mentored field reporting personnel
 - Identified expert reporting analysts at many sites
 - Feb 2015 use of procurement reports is 270% of FY 13 usage
- What's Up Next?
 - Make pre-award data available in the PIC (for authorized users)
 - More complete and current FPDS-NG data
 - Enhance online documentation about available reports



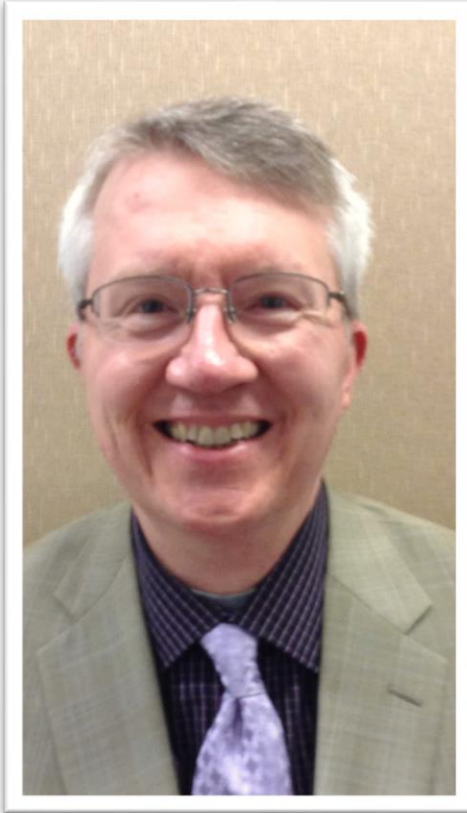
- Since Last Workshop...
 - Implemented FedDataCheck
 - Continuously monitors data in FPDS-NG
 - Sends alerts directly to contracting officers/specialists
 - Created reports to monitor accuracy between STRIPES & FPDS-NG
 - Revised the Quarterly Data Quality Review process
 - Reviewing 100% of actions for accuracy, instead of only sampling
 - Significantly reduced workload on the field
- What's Up Next?
 - Add ability to pre-check data quality before release of documents
 - Build upon existing capabilities to improve data quality

- Procurement Systems Working Group (Biweekly)
 - Reps from most procurement offices
 - Address problems raised by the field
 - Review/approve change requests
 - Spawn sub-working groups on an *ad hoc* basis
 - Continuous Learning Points (CLPs) awarded for participation!
- Executive Steering Committee (Monthly)
 - HCAs/SPEs and senior MA & CF executives
 - Set direction and identify major goals
- Reference materials on Powerpedia
 - System Information, meeting minutes, forms, etc.
 - Search for PSWG to get started
 - Much more coming on EPiC

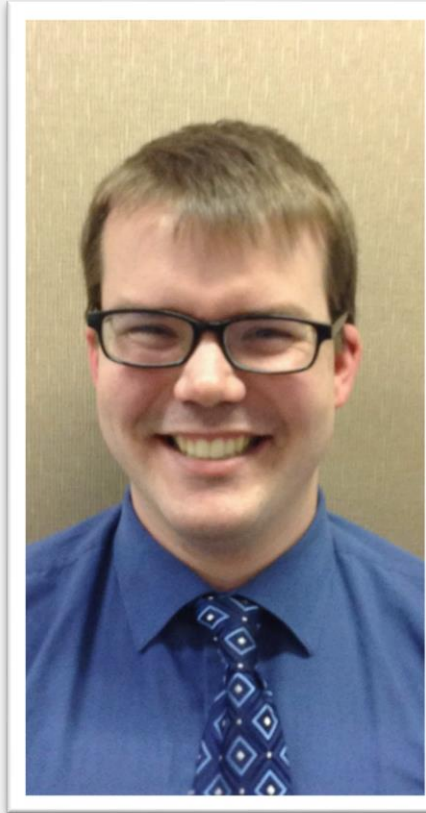
- Keep up!
 - Follow the PSESC/PSWG with materials on Powerpedia
 - Get to know your Working Group member
 - Make sure they're keeping your site informed
- Speak up!
 - Let us know about your problems & concerns ... Don't suffer in silence!
 - Ask your site rep to raise the issue to the PSWG
 - Submit a Change Request
- Step up!
 - Become a reporting expert (BI-JEDI)
 - Volunteer to participate in a Sub-Working Group
 - Volunteer to help with User Acceptance Testing (UAT)

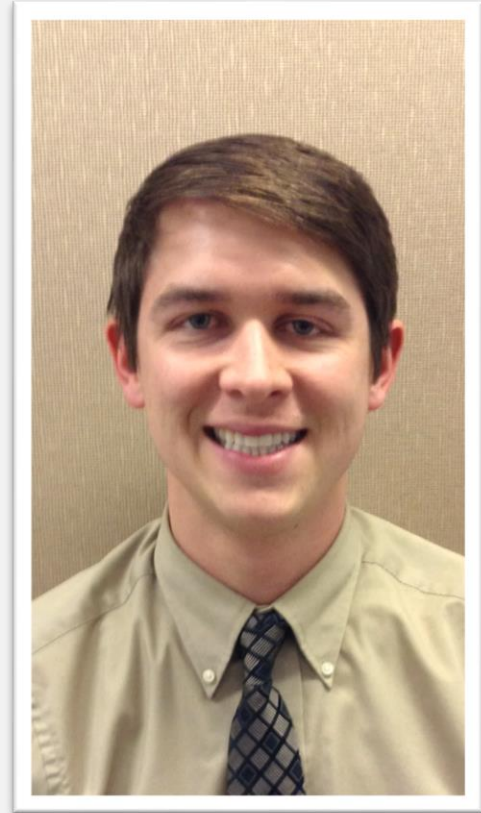
