## National Chairs Meeting-Idaho Falls, Idaho

Northern New Mexico Citizens' Advisory Board Chair Mr. Carlos Valdez, Vice-Chair Mr. Doug Sayre and Board Member Ms. Allison Majure, with NNMCAB

staff attended the Fall 2014 Chairs meeting in Idaho Falls this past September. The members had the opportunity to tour the Idaho National Laboratory (INL) site, which covers 890 square miles in southeastern Idaho. The site tour took the members

to the Experimental Breeder Reactor 1 (EBR-I) a national historic landmark noted as the worlds first nuclear power plant. At the EBR-I Museum the members were also able to see two aircraft nuclear propulsion prototype engines.

NNMCAB members attended the meetings on the subsequent days. During

the meeting one of the topics of great concern was the status and future of the Waste Isolation Pilot Plant (WIPP) located in southern New Mexico, and the current problem

with the shipping of Transuranic waste. In an effort to address the issue, NNMCAB Members Sayre and Majure helped draft a national recommendation on WIPP. The recommendation that was approved during the meeting, recommended DOE look at the possibility of temporary above ground storage

at the WIPP site. The recommendation was forwarded to the boards across the complex for their approval.

## What is the Northern New Mexico Citizen's Advisory Board (NNMCAB)?

Environmental Management Site-Specific Advisory Boards were developed to involve stakeholders more directly in the Department of Energy (DOE) cleanup process. The NNMCAB provides DOE with advice and recommendations concerning: environmental remediation, waste management, and monitoring and surveillance of legacy waste at LANL.

#### Who Serves on the NNMCAB?

Membership reflects a broad range of cultures, demographics, and views from citizens in the affected communities and regions. Members include stakeholders from local governments, Tribal Nations, environmental and civic groups, universities, labor organizations, and others. Liaisons to the NNMCAB come from LANL, DOE, the Environmental Protection Agency, and the New Mexico Environment Department.

### **Board Member Responsibilities**

\* Submitting advice and recommendations to DOE on integral Environmental Management Issues.

- Representing and communicating the views of their communities in board discussions.
- Keeping the public informed on key issues, upcoming decisions, board recommendations, and public hearings.
- \* Attending the NNMCABs bi-monthly meetings and serving on one of the boards standing committees. Board meetings occur Bi-monthly on Wednesdays from 1:00 p.m. to 5:00 p.m. Committee meetings occur on the 2nd Wednesday of every month from 2:00p.m. to 4:00 p.m.

#### How Can You Get Involved?

Board meetings serve as a two-way exchange between members of the public and the NNMCAB, DOE, and Liaisons. All NNMCAB board meetings have a public comment period through which members of the public can voice their concerns, and submit written comments.

Being involved with the NNMCAB for the past two years has certainly been enlightening as well as giving me insight, worthwhile information, knowledge and learning as to many of the concerns and needs regarding the legacy waste from LANL's operations from the last 70 some years. Being a lifelong resident of Santa Fe and frequently going to the Hill for various activities over the years, a person gets a very different and often unknowledgeable view of the operations of LANL and DOE. Being on the NNMCAB and having very competent fellow members, Board Staff, DOE DDFOs, EPA, LANL, NMED liaisons, all of whom are very willing and accommodating in providing important pertinent information help make the NNMCAB more educated and

knowledgeable about the legacy waste problems. This collaboration definitely makes for a more learned and informed Board officers and members who are then able to more adequately and reliably consider, advise and recommend on needed items, issues, or documents of legacy waste concern.

I recommend for the upcoming year the NNMCAB consider and/or continue the following activities: 1)Work with DOE and LANL staff to re-establish the Campaign Approach consideration so that the Board can help with prioritization and public involvement with the process. 2) Increase Board membership by involving additional representative community members, especially women, and possibly Pueblo Tribal members from all area pueblos. 3) Work more closely with the Buckman Direct Diversion Board and staff to insure when runoff from Bayo, Pueblo, DP, and Los Alamos Canyons occurs, that the BDD staff are adequately notified so that the diversion structure

can be adjusted or turned off to let unwanted Rio Grande flow by-pass the diversion structure. If there are some other matters or concerns related to the diversion that the BDD Board would like to be addressed, the NNMCAB consider taking them under advisement for presentation to DOE/LANL. 4)Request that LANL and DOE continue to provide updated reports concerning the monitoring and status of the MDA's A, B, and T at Technical Area 21 and MDA G at Technical Area 54 on the disposition of the waste in the "Generals Tanks," the Pits, the Trenches, and the Shafts associated with these disposal areas. 5) Request that LANL provide a detailed report relating to the Groundwater Monitoring completed in 2012-13 and any significant findings that might be considered potential contamination areas. Also advise if additional monitoring wells are planned and if additional sample frequency of any areas are planned.

### 2014 Rad Waste Summit Summerlin, Nevada

This year's Rad Waste Summit was held in Summerlin, Nevada, September 2<sup>nd</sup> thru 5<sup>th</sup>. Attending from the Northern New Mexico Citizens' Advisory Board was Joseph Viarrial and myself. Tuesday the 2<sup>nd</sup> was a travel and registration day. The travel day was extra special for me, due to the fact that I ran into DOE Secretary Ernest Moniz at the Sunport before boarding my flight. Yes, I was able to get a picture with him! Wednesday, Thursday, and Friday were full days of meetings and exhibits.

The first session on Wednesday morning was exciting in that NMED Secretary Ryan Flynn spoke at length about the WIPP events. He was encouraged that although DOE got off to a slow start in responding to the incidents, they have since shown much more attention to the matter and are responding in a positive manner. DOE has implemented several teams,

to include a multi-lab technical assessment team, are sponsoring weekly town hall meetings, and have implemented an acceptable recovery plan. He did mention however, that the pace of the investigation was too slow.

His plan for WIPP includes:

- 1. Identify the root cause
- 2. Close panels immediately
- 3. EM must be given control of Legacy waste clean-up at LANL and throughout the complex
- 4. Eliminate the silo effect at WIPP and all generator sites
- HQ should not manage recovery operations from DC, they need "boots on the ground"

Frank Marcinowski also spoke at the session. He assured everyone that DOE is committed to opening WIPP safely, and as quickly as possible.

We also heard perspectives from contractors, a few of the generating sites, and the Nevada Advisory Board as well. There were several other speakers at the event; however, WIPP was undoubtedly the topic of conversation at the Summit.

Overall, this was one of the best conferences I've attended. It was informative, very interesting, well-attended, and I would highly recommend future attendance by CAB members. I can be available to speak to members more about the Summit off-line, if desired.



## Say Farewell to Outgoing Member Villarreal

Mr. Bob Villarreal retired from the Department of Energy in 2008 after 45 years of service as a research chemist and nuclear reactor operator. He has worked on over 5 different reactors from the Borax V to the Zero Power Plutonium Reactor. During his 45 year career Mr. Villarreal was a project and program lead for the LANL Chemical and Metallurgical group and at one point he was appointed as the Argonne West Analytical Laboratory Manager.

Mr. Villarreal was appointed to the NNMCAB November 7, 2008 to fill a vacated seat. On November 15, 2014 he will complete his third term. Mr. Villarreal has an extensive list of over a hundred technical reports and publi-

cations he authored including his most recent in 2008, "Technical Guide



to the Observation and Recognition of an Actinide Nuclear Weapons Material." Mr. Villarreal has a Masters Degree in Chemistry from the University of Idaho, and has brought a wealth of knowledge and experience to the NNMCAB. During his time on the

NNMCAB, Mr. Villarreal has served on the Environmental Monitoring & Remediation subcommittee. He has become an advocate for the removal of the 33

Shafts at Los Alamos National Laboratories Technical Area 54. A project that he had previously worked on during his time at the Lab.

The NNMCAB members and staff wish Mr. Villarreal the best in all of his future endeavors, and hope to see him at future meetings as a member of the public.

At the July 30, 2014 NNMCAB meeting the Board approved Draft Recommendation 2014-02 "Institution of Measures to Help Ensure WIPP and LANL Transuranic Disposal Operations Remain Continually Operational." The NNMCAB sub-committees are also working to draft additional recommendations on WIPP and environmental clean-up issues.
