Change of Proposed Site of SeaOne's CLG Production and Shipping Facility

Dear Mr. Anderson:

On June 3, 2014, SeaOne Pascagoula, LLC ("SeaOne") submitted an application in Docket No. 14-83-CGL seeking authority for long-term, multi-contract authorization to export domestically produced Compressed Gas Liquid (CGL) to any country with which the United States currently has, or in the future will have, a free trade agreement. On December 2, 2014, DOE/FE issued Order No. 3555 granting SeaOne authorization to export CGL to any FTA country located in or adjoining the Caribbean Basin and the Gulf of Mexico, provided that the destination nation has the capacity to import the natural gas contained in or mixed with CGL via ocean going vessels.

Based on discussions with and recommendations from the Governor of Mississippi and his staff, SeaOne has decided to move the proposed site for its initial CGL production and shipping facility from the Port of Pascagoula to the Port of Gulfport. The Port of Gulfport is governed and managed by the State of Mississippi, and is not within the city limits of the City of Gulfport, simplifying the regulatory process. The Gulfport site is also an existing site that will not require greenfield development; is not near any residential areas; and does not present any restrictions on the size of vessels or transit operations for current and expanded markets, thus facilitating potential future expansion. The source and point receipt of feedstock for CGL production remains unchanged from that described in SeaOne's July 18, 2014 filing (feedstock will be delivered, via a new offtake pipeline located upstream from BP's existing Pascagoula



Gas Processing Plant in Jackson County Mississippi, to SeaOne's dedicated and single purpose private plant pipeline).

To reflect the change to the Gulfport site SeaOne has filed articles of amendment with the Secretary of State, State of Mississippi, to change the limited liability company's name to SeaOne Gulfport, LLC. There has been no change in the ownership or corporate structure of the limited liability company, nor does this name change result in a change of control. Nor have the goals and objectives of the project changed from those described in SeaOne's June 3, 2014 application.

Accordingly, pursuant to 10 C.F.R. § 590.204, SeaOne respectfully requests that DOE/FE amend Order No. 3555 to reflect the change in the location of the proposed point of shipment (to the Port of Gulfport, Mississippi) and the corresponding name change (to SeaOne Gulfport, LLC).

Attached hereto is a copy of the Mississippi-issued certificate verifying the name change.
