

Discussion: Reflections and Ideas (slide 1 of 2)

Financing:

- Currently, the responsibility for investments in retrofits and upgrades rests on homeowners, which has created very slow growth for residential EE. How can we shift the onus of investment to utilities?
 - On-bill financing is one strategy.
- Outreach to low-income neighborhoods and providing sufficient financing options remains a challenge for many programs.
 - More education and training is needed on no-cost energy efficiency improvements
- Combining public and private funding could lead to better financing options
 - The Tennessee Valley Authority is operating an "Extreme Energy Makeover" program to offer deep-retrofits to low-income homes, financed in part through an EPA agreement. More about the program <u>here</u>.





Discussion: Reflections and Ideas (slide 2 of 2)

Marketing and Outreach:

- Interested in hearing more about employer-based energy efficiency programs
- The residential housing stock is the most difficult sector to reach and scale for programs. Strategies for further discussion through a peer exchange call:
 - Bundling financing and tax incentives
 - Reducing utility costs to the homeowner

Working with Contractors:

- Consumers don't know who to hire for improvements and will often just live with energy issues rather than seek out a contractor
- Programs continue to run into issues with contractor performance and quality assurance





Future Call Topic Ideas Suggested by Participants

- The challenges, and strategies to overcome, with scaling programs between different utilities or across jurisdiction boundaries where policies may differ
- Clean Power Plan rule and what it means for energy efficiency
- ESCO (energy services company) model for residential energy efficiency
- Little- to no-cost energy saving interventions
- New developments in building materials and retrofit technologies
