
On November 23, 2016, Dominion Cove Point LNG, LP (“DCP”) submitted an application in Docket No. 16-205-LNG seeking authority to export liquefied natural gas (“LNG”) by vessel in volumes up to the equivalent of 250 Bcf of natural gas. On June 2, 2017, DOE/FE issued Order No. 4046 granting DCP’s request.

On May 12, 2017, DCP amended its Certificate of Limited Partnership with the State of Delaware to change the limited partnership’s name to Dominion Energy Cove Point LNG, LP (“DECP”). Attached hereto is a copy of the Delaware issued certificate verifying the name change and its effective date. This is strictly a name change; there has been no change in the ownership or corporate structure of the limited partnership, nor does this name change result in a change of control.

DECP respectfully requests that DOE/FE Order No. 4046 be amended to reflect Dominion Energy Cove Point LNG, LP as the holder of such authorization, and that DOE/FE grant any waivers necessary to allow the name change to be effective as of the date set forth on the attached certificate.
