Proposed Action or Project Description

American Recovery and Reinvestment Act:

1) Acquisition of services to support development of an energy efficiency and conservation strategy and a comprehensive strategic energy plan (ongoing); 2) establishment of a weatherization program for homes including support of start-up of weatherization contractors; financial incentives for homeowners; community outreach and promotion; and monitoring, verification, and reporting; 3) implementation of a small business energy efficiency initiative to provide low-cost energy efficiency retrofits to targeted businesses in the city including outreach and promotion; a rebate program; and monitoring, verification and reporting; 4) creation of a municipal energy office; 5) conduct feasibility study for installation of up to 12 solar photovoltaic systems on city-owned sites to provide a renewable energy generation capacity of up to 1 MW (ACTIVITY 5 EXCLUDES INSTALLATION FROM NEPA APPROVAL); 6) initiation and implementation of a comprehensive energy conservation and efficiency strategy for city-owned buildings including benchmarking, re-commissioning, and acquisition of a contractor to execute an energy savings performance contract for a number of city-owned buildings; and 7) retrofit of a number of municipal buildings to improve energy efficiency (ACTIVITY 7 IS EXCLUDED FROM NEPA APPROVAL)

Conditions: None - EXCLUDES INSTALLATION OF SOLAR PHOTOVOLTAIC IN ACTIVITY 5 AND

BUILDING RETROFITS IN ACTIVITY 7

Categorical Exclusion(s) Applied: A1, A9, A11, B1.32,
