Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

The Illinois Department of Commerce & Economic Opportunity (DCEO) has submitted the following three projects totalling \$1,297,908 that fall within the NEPA SEP TEMPLATE.

Kraft Foods, Naperville: The project is to implement a waste heat recovery system to replace the existing natural gas heating and steam system. The project will use waste heat from the baking ovens to heat all process and domestic hot water in the plant.

Kraft Foods, Chicago Bakery: The project is to implement a waste heat recovery system to replace the existing natural gas heating and steam system. The project will use waste heat from the baking ovens to heat all process and domestic hot water in the plant.

Rentech Energy Midwest: The project is to retrofit existing compressors at the fertilizer manufacturing plant with a lean burn conversion package. The project will reduce the consumption of natural gas and reduce greenhouse gas emissions from the plant.

The State has provided clarifying language addressing building aesthetics, National Historical Preservation Act, and will comply with all applicable federal, state and local laws on the handling, storage and disposal of waste. The work identified will not increase or impact the footprint of the current facilities.

Based on the information provided by the State, these projects fall within the bounds of the previously signed NEPA Template and are categorically excluded under B5.1 "actions to conserve energy."
