Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

CX, EA, EIS APPENDIX AND NUMBER:

Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

The City of Jacksonville would implement a Clean Demonstration Program at the Tree Hill Nature Center (7152 Lone Star Rd. Jacksonville, FL 32211), as well as install solar hot water heaters at 30 neighborhood fire stations.

The Demonstration project would consist of the installation of a 10kW photovoltaic (PV) system, along with the installation of a groundwater-based geothermal heating and cooling system which would retrofit the Center's existing heating and cooling system. The geothermal installation would be limited to two 5-ton open-loop systems. Additionally, the City would install solar hot water heating systems at 30 neighborhood fire stations throughout the Duval County area.

Installation of the photovoltaic system at the Tree Hill Nature Center, and the installation of solar hot water heating systems at 30 neighborhood fire stations constitute actions to conserve energy and are therefore categorically excluded under NEPA under CX B5.1.

Installation of the geothermal system is not categorically excluded from NEPA at this time pending further review of the potential environmental impacts of the proposed action.

NEPA PROVISION

DOE has made a conditional NEPA determination for this award, and funding for certain tasks under this award is contingent upon the final NEPA determination.

Insert the following language in the award:

You are restricted from taking any action using federal funds, which would have an adverse affect on the environment or limit the choice of reasonable alternatives prior to DOE/NNSA providing either a NEPA clearance or a final NEPA decision regarding the project.

Prohibited actions include:

Demolition, construction, removal, installation or disposal activities associated with the geothermal heating and cooling system component of this activity pending a final NEPA determination from DOE.

This restriction does not preclude you from:

Implementing all actions associated with the solar PV and solar hot water system installations.

If you move forward with activities that are not authorized for federal funding by the DOE Contracting Officer in advance of the final NEPA decision, you are doing so at risk of not receiving federal funding and such costs may not be recognized as allowable

cost share.

Insert the following language in the award:

You are required to:

If you intend to make changes to the scope or objective of your project you are required to contact the Project Officer identified in Block 11 of the Notice of Financial Assistance Award before proceeding. You must receive notification of approval from the DOE Contracting Officer prior to commencing with work beyond that currently approved.

Recipient shall ensure the safety and structural integrity of any repair, replacement, construction and/or alteration performed under this project.

Prior to the expenditure of Federal funds the recipient has the affirmative responsibility to ensure that it has a waste management plan addressing waste generated by their proposed actions. The plan will describe the plan to dispose of any sanitary or hazardous waste, e.g. construction and demolition debris, old light bulbs, lead ballasts, piping, roofing materials, discarded equipment, debris, packaging materials, asbestos, etc. generated as a result of the proposed project. The recipient must ensure that it will comply with all federal, state and local regulations for waste disposal.

NHPA Requirements

Prior to the expenditure of Federal funds to implement the above activity, the recipient has the affirmative responsibility to ensure compliance with Sec. 106 of the National Historic Preservation Act (NHPA). Section 106 applies to historic properties, districts, etc... that are listed in or eligible for listing in the National Register of Historic Places.
