American Recovery and Reinvestment Act:

1) Replace air-cooled condenser unit at Mentor City Hall, 2) boiler replacement at Mentor City Hall, 3) parking lot lighting and public area lighting replacements, 4) traffic signal lighting replacement with LEDs, 5) water heater/boiler replacement at the Civic Ice Arena (built in 1982), and 6) installation by contractor of LED traffic signal bulb retrofits
