Description:

- A9 Information gathering (including, but not limited to, literature surveys, inventories, audits), data analysis (including computer modeling), document preparation (such as conceptual design or feasibility studies, analytical energy supply and demand studies), and dissemination (including, but not limited to, document mailings, publication, and distribution; and classroom training and informational programs), but not including site characterization or environmental monitoring.
- A11 Technical advice and planning assistance to international, national, state, and local organizations.
- B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. Activity 10 & Activity 11: Lighting and boiler replacement at Jefferson County Courthouse Secure Parking Building Activity 12: 750 ton Chiller replacement at Jefferson County Courthouse (This is a second chiller replacement in the same building as a previously approved activity (#5: 600 ton chiller retrofit).

Activity 13: Replace Youth Detention Center Lighting (Retrofits)

Activity 14: Retrofit Lighting Ballast & Bulbs in Bessemer Courthouse Annex Parking Deck

Activity 15: Hickory Ridge Phase II; EECBG funds would be used to pay for incremental energy efficiency features at the Hickory Ridge Residential Community for the Elderly.

All other activities associated with this SOW, including Activities 1 - 9, were categorically excluded from further NEPA review by DOE either at the at the time of award or during the initial project SOW review.
