Proposed Action or Project Description

American Recovery and Reinvestment Act:

1) Complete feasibility study: acquisition of technical services to develop the Lummi Indian Reservation Energy Development Feasibility Assessment (wind power) and (to support the assessment) installation of two meteorological towers (one approximately 60 meter and one approximately 50 meter) to gather information.
