Description:

- B5.1** Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.
- A11** Technical advice and planning assistance to international, national, state, and local organizations.
- A9** Information gathering (including, but not limited to, literature surveys, inventories, audits), data analysis (including computer modeling), document preparation (such as conceptual design or feasibility studies, analytical energy supply and demand studies), and dissemination (including, but not limited to, document mailings, publication, and distribution; and classroom training and informational programs), but not including site characterization or environmental monitoring.

Rational for determination:

Illinois Department of Commerce & Economic Opportunity (DCEO) has submitted a signed, NEPA bounded template for their Energy Efficiency Development market title, Large Customer activity, and their Manufacturing/Processing market title, Green Industry Business Development activity. DCEO intends to fund cost shared grants related to the purchase and/or installation or modification of energy efficiency equipment/measures within existing facilities.

IL has provided clarifying language addressing building aesthetics, National Historical Preservation Act, and will comply with all applicable federal, state and local laws on the handling, storage and disposal of waste. All of these requirements will be incorporate into the project award documents. There will be no new construction in any of these projects. The projects will be selected through an RFP process and will be awarded through their e-grants financial program.
