Description:

- Information gathering (including, but not limited to, literature surveys, inventories, audits), data analysis (including A9 computer modeling), document preparation (such as conceptual design or feasibility studies, analytical energy supply and demand studies), and dissemination (including, but not limited to, document mailings, publication, and distribution; and classroom training and informational programs), but not including site characterization or environmental monitoring.
- B3.6 Siting, construction (or modification), operation, and decommissioning of facilities for indoor bench-scale research projects and conventional laboratory operations (for example, preparation of chemical standards and sample analysis); small-scale research and development projects; and small-scale pilot projects (generally less than two years) conducted to verify a concept before demonstration actions. Rational for determination:

The University of Memphis, in collaboration with Mid-South Community College proposes to use federal funds to design, fabricate, and bring online a biofuel micro-refinery within existing infrastructure.

This project will consist of laboratory research aimed at enhancing existing BEST (Biofuel Energy Sustainable Technologies) micro refinery at the University of Memphis located in room 115 of the Engineering Sciences building. This will consist of analyzing and enhancing pretreatments of feedstock, post reaction processing, and process flow. The Mid-South Community College will construct a micro-refinery within an existing structure on campus. Money from this project will go toward funding the equipments and installation. This will include a biomass gasification unit, diesel generator, & Fischer-Tropsch synthesis unit.

This R & D project will include a feed rate of 50 to 100 kg/hr to create 2200 to 4400 cubic feet/hr of syngas flow.

The applicant has submitted an R & D Questionnaire which thoroughly addresses the chemical and safety handling protocols at each university where this project will take place.

This project is comprised of information gathering, bench scale research, and on site characterization to include the installation of equipment; therefore DOE has recognized that this project qualifies for the categorical exclusions of A9, B3.1 & B3.6.
