Categorical Exclusion for Emergency Crossarm Replacement at Structures 3/3 and 38/8 along the existing Coolidge -Oracle 115-kV Transmission Line in Pinal County, Arizona

## **RECORD OF CATEGORICAL EXCLUSION DETERMINATION**

A. <u>Proposed Action</u>: Western proposes to conduct Emergency Crossarm Replacement at Structures 3/3 and 38/8 along the existing Coolidge-Oracle 115-kV transmission line. We will use existing access roads and rubber tired vehicles such as pickup trucks, crew trucks, and bucket trucks to bring personnel and equipment to the work area. This work is necessary to maintain the safety and reliability of the bulk electrical system.

The attached map shows the project areas are situated within Sections 7 Township 5 South Range 9 East & Section 12 Township 9 South Range 12 East on the Gila and Salt River Meridian, Pinal County, Arizona. Work will be conducted within Western's right of way. The corresponding U.S.G.S. 7.5-minute topographic maps are Florence & Chief Butte, Arizona.

B. <u>Categorical Exclusion Applied:</u> 10 CFR, Part 1021, Subpart D, Appendix B,B1.3. "Routine maintenance activities and custodial services for buildings, structures, rightof-way, infrastructures (e.g. pathways, roads and railroads), vehicles and equipment and localized vegetation and pest control during which operations may be suspended and resumed."

## C. Regulatory Requirements in 10 CFR 1021.410 (b):

- 1. The proposed action fits within a class of actions that is listed in Appendix B to Subpart D.
  - a. The proposed action was reviewed for the requirements of the Endangered Species Act, the National Environmental Policy Act (NEPA), the National Historic Preservation Act, and all applicable Department of Energy Orders. This action falls under the Programmatic Agreement for routine maintenance activities, type II activities.
  - b. The proposed action does not require the siting, construction, or major expansion of waste storage, disposal, recovery, or treatment facilities.
  - c. The proposed action does not disturb hazardous substances, pollutants, contaminates, or CERLA-excluded petroleum and natural gas products that pre-exist in the environment such that there would be uncontrolled and unpermitted releases.
  - d. The proposed action was reviewed and surveyed for impacts to cultural and sensitive biological resources. Cultural and sensitive biological resources have been determined to not be affected.

- 2. There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal; and
- 3. The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.
- D. <u>Determination</u>: Based on my review of information conveyed to me and in my possession (or attached) concerning the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1A), I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
- E. Special Conditions:
  - 1) Only rubber-tired vehicles will be used to accomplish the work.
  - 2) Blading, grading or leveling the ground surface will be avoided.
  - 3) An archaeological monitor will be present during work at Structure 38/8.
  - 4) At Structure 38/8, all vehicles will stay within 100 feet of the gate on the access road from Park Link Road; Do not use the access road turn-around in front of the corral.



Structure #3/3 & #38/8 Emergency Crossarm Replacement


