Proposed Action Title: (0472-1537) Northeastern University - Multiscale Development of L10 Materials for Rare-Earth-Free Permanent Magnets

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): New York, Michigan, Massachusetts, and Nebraska.

Proposed Action Description:

Funding will support the development of an ultra-strong ferromagnetic magnet material with a tetragonal L10 structure, that does not contain rare earth materials and is designed for use in clean energy technologies such as electric vehicle motors and wind turbine generators. Northeastern University's application was selected for an initial 18-month period (Phase 1) of funding. The ARPA-E Program Director may decide to negotiate and fund project activities for an additional 18-month period (Phase II) after evaluating the work performed in Phase I. ARPA-E has not obligated funds or negotiated a scope of work for Phase II at this time. Accordingly, this categorical exclusion determination form addresses only the activities that will occur in Phase I of this project.

Proposed work will consist of (1) synthesisizing, processing, and characterizing FeNi and MnAl nanocomposites; (2) evaluating and validating theoretical determinations and predictions of electronic structure and atomic-scale magnetic properties through computer modeling and numerical simulations; and (3) creating hot and cold-pressed compacts of optimized L10 materials.

Proposed work will take place at Northeastern University (Boston, MA), Arnold Magnetic Technologies Corporation (Rochester, NY), General Motors Research and Development Tech Center (Warren, MI), Columbia University (New York, NY), University of Massachusetts (Amherst, MA), and University of Nebraska (Lincoln, NE).
