#### Structure Replacement Flaming Gorge-Vernal No. 3 138-kV transmission line (Structure No. 25/6) Spring 2012

- A. Brief Description of Proposal: Western Area Power Administration (Western) proposes to replace Structure No. 25/6 on the Flaming Gorge-Vernal No. 3 138-kV transmission line. The structure is located on Bureau of Land Management lands in Uintah County, Utah (Township 3S, Range 22E, Section 7; Donkey Flat 7.5' USGS quadrangle). Work consists of removal and in-kind replacement of the wood H-frame structure and anchors utilizing rubber tired vehicles, crane, bucket truck, pole trucks/trailers, auger rig, and pick-up trucks. All work will be conducted on Western's existing right-of-way.
- B. Number and Title of the Categorical Exclusion Being Applied: (See text in 10 CFR Part 1021, Subpart D.)

#### B4.6 Additions and modifications to transmission facilities

Additions or modifications to electric power transmission facilities within a previously disturbed or developed facility area. Covered activities include, but are not limited to, switchyard rock grounding upgrades, secondary containment projects, paving projects, seismic upgrading, tower modifications, load-shaping projects (such as the installation and use of flywheels and battery arrays), changing insulators, and replacement of poles, circuit breakers, conductors, transformers, and crossarms.

- C. <u>Regulatory Requirements in 10 CFR 1021.410 (b)</u>: (See full text in regulation and attached checklist.)
  - 1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal <u>must not</u>:

- Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;
- Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;

Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).

- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

#### D. Special Stipulations Pertaining to the Proposal:

If the scope of work of this project changes, Western's Environmental Division must be contacted for additional environmental review.

This Categorical Exclusion is valid for 3 years after the signature date. If construction has not commenced within that time, Western's Environmental Division must be contacted for an updated environmental review prior to construction.

If any cultural materials are discovered during construction, work in the area shall halt immediately, Western and the Utah SHPO staff shall be contacted, and the material be evaluated by an archaeologist or historian meeting the Secretary of the Interior's Professional Qualification Standards (48 FR 22716, Sept. 1983).

Based upon Bureau of Land Management Vernal Field Office recommendations, the following conditions shall apply:

- All work shall be conducted using existing access roads and Western's right-of way (ROW).
   Any deviations from existing ROW will require further coordination.
- Before and after photos will need to go into the corresponding project file to show that maintenance was completed.
- E. <u>Determination</u>: Based on my review of information provided to me and in my possession concerning the proposed action, I determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
