Proposed Action or Project Description: American Recovery and Reinvestment Act:

1) Energy efficient retrofits occupancy sensors in the Police Department, City Hall, and Community Activities Center, 2) lighting retrofits at the City Library, 3) installation of reflective roof coatings and HVAC units at the Community Activities Center, City Hall, and Library, 4) installation of above ground storage tank for E-85 to be used for fleet vehicles, 5) lighting upgrades at the Police Department, City Hall, Community Activities Center, Animal Control, Information Technology, Senior Center, Fire Station 1, Fire Station 4, and the Bessie Mitchell House and purchase of a bulb eater to crush bulbs at the city service center instead of storing bulbs for disposal; 6) installation of solar hot water heaters at water treatment plant, and 7) installation of solar photovoltaic panels at the water treatment plant.
