Rational for determination:

The U.S. Department of Energy (DOE) provided \$442,647 of federal funding to the Arizona State Energy Office (SEO) under the DOE's Annually Appropriated State Energy Program (SEP) for 2012. The SEO will match the federal funding with \$68,590 in state fundsfor a total of \$511,237.

The SEO proposes to fund the following Market Titles:

Alternative Fuels:

Under this Market Title, the SEO would work with Clean Cities coalitions and commercial entities operating in the state to establish infrastructure for plug-in hybrid vehicle recharging. The SEO would also explore the possibility of using solar photovoltaics to recharge such vehicles during the day in covered parking structures.

Community Energy Program:

Under the Market Title rural Arizona communities and businesses would be provided energy education, technical assistance, and long-range planning to develop sustainable energy management through.

Education and Community Outreach:

Under this Market Title, the SEO would establish and maintain a website, provide a variety of energy-related information for state policy makers and Arizona residential consumers. Conferences, workshops, and educational and public forums would provide presentations and information to target audiences.

Energy Data, Analysis and Evaluation:

Under this Market Title, the SEO would compile Arizona-specific energy data on gasoline consumption, average prices, and EIA gasoline analysis. The SEO would monitor news articles to track energy-related programs, projects, companies and issues for daily or weekly email distribution for state policy makers and the general public.

Energy Efficient New Commercial Construction and Renovation: Under this Market Title the SEO would develop partnerships with utilities and the green building community to provide training and technical assistance to building owners from various sectors.

Energy Efficient Schools:

Under this Market Title, the SEO would provide assistance and guidance to school districts in the development and implementation of energy efficiency strategies for school facilities.

Professional and Program Administrative Support:

Under this Market Title, funding would be used for administrative salaries, indirect costs, to provide support services, and fulfill fiduciary responsibilities for the FY12-13 SEP.

Renewable Energy:

Under this Market Title, funding would be used by the Governor's Office of Energy Policy to promote the development and utilization of renewable energy under the state's and federal incentive.

Residential Technical Transfer:

Under this Market Title, the "Whole House" concept would be promoted and would focus on the incorporation of basic building science techniques throughout the building process.

State Building Energy Efficiency Program:

Under this Market Title, the SEO would provide technical assistance to state government departments, agencies, universities and community colleges.

The market titles/programs funded under the SEP Formula grant are of an administrative nature and included in the description in the Market Titles/Annual Files. All funds will be used for program administration and coordination, salaries, fringe benefits, travel to conferences, office supplies, and the planning and development of education and outreach programs. No ground disturbing activities, construction or building retrofitting will occur with this funding

Based on a review of the activities that would be funded under the above Market Titles, DOE has determined the projects that would be funded under these Market Titles will not significantly impact the human environment and they are categorically excluded from further NEPA review under CX A9 "information gathering" and CX A11 "technical advice."
